On behalf of the Washington State Medical Association (WSMA), representing the state's physicians and physician assistants, we appreciate the opportunity to provide comment in support of Washington state's Section 1332 Waiver application to remove federal barriers to health care coverage and allow all Washingtonians the same opportunity to purchase Qualified Health Plans (QHPs) through the state-based marketplace, regardless of immigration status. We are grateful for the continued partnership with the Health Benefit Exchange (Exchange) as we have worked towards our shared goal of improving access to affordable health care coverage.

The Section 1332 Waiver is another step toward expanding access to care, particularly among communities who have been historically excluded from obtaining affordable and comprehensive coverage. Washington is home to over 100,000 uninsured immigrants who are integral members of our communities but who are ineligible for Medicaid or QHPs because of their immigration status. The WSMA supports access to affordable, comprehensive, high-quality health care coverage that is designed to encourage participation of physicians and practices. Firelands is a community-based organization of low-wage workers in the natural resource and care sectors. Our members experience poverty or precarity, from unemployment to 12-hour shift seasonal work, to substandard housing, and lack of health care. The impacts of poverty, precarity and crisis are not only physical illness but also mental health challenges including stress, anxiety and depression. A multiracial organization, our members are majority Latina/o and Indigenous immigrants from Mexico and Central America, the majority women, with a range of immigration statuses.

Our members are directly harmed by lack of access to the Exchange. For example: One Firelands member has only visited the doctor once in twelve years because of her fear of medical bills. Another member must have medically-necessary surgery but is delaying it and considering not getting it because of her fear of the bill. Many of our members have diabetes and have to pay out of pocket for their medical costs; they are often forced to skip their medication or choose between medication, food, or rent, due to lack of health insurance. To Whom it May Concern,

On behalf of the Kitsap Public Health District in Bremerton, Washington, I am writing to voice our support of Washington State's application for a 1332 waiver. The waiver will enable all Washingtonians, regardless of immigration status, to be able to purchase health insurance coverage through Washington Healthplanfinder and allow all qualifying low-income residents to benefit from Cascade Care Savings, Washington State's new assistance program.

This waiver will help increase Washingtonians' access to health insurance, which can, in turn:

- increase the chance for more people to have positive health outcomes. According to Healthy People 2030, having health insurance "is associated with improved access to health services and better health monitoring" and is "critical for enabling children with special health needs or chronic illnesses to access health services." Not having health insurance reduces the likelihood of adults and children receiving preventative services and treatment for conditions. In 2019, three in 10 uninsured adults went without needed medical care due to cost (Kaiser Family Foundation, 2020). Even with the passing of the Affordable Care Act, many uninsured individuals say they lack insurance coverage due to its high cost. In 2019, uninsured nonelderly adults were over twice as likely as those with private coverage to have had problems paying medical bills in the past 12 months ((Kaiser Family Foundation)
- promote equity. Families with low incomes and people of color are more likely to be uninsured (Kaiser Family Foundation, 2020). These populations already experience long-standing health and economic disparities, which were exacerbated by the COVID-19 pandemic (U.S. Health and Human Services, 2021). In 2020, among the nonelderly population, 26% of lawfully present immigrants and 42% of undocumented immigrants were uninsured compared to 8% of American citizens (Kaiser Family Foundation, 2022). Everyone in Washington State, regardless of their income, race, immigration status, or other factors should have a fair opportunity to thrive and be healthy. On behalf of the physician and medical student members of the American Medical Association (AMA), I appreciate the opportunity to provide public comment in support of Washington State's Section 1332 Waiver application. Covering the uninsured and improving health insurance affordability have been long-standing goals of the AMA, and we believe that approval of this waiver application will advance those goals in Washington State.

We know that, nationally, lawfully present and undocumented immigrants are more likely to be uninsured than citizens. Among the nonelderly population, 26 percent of lawfully present immigrants and 42 percent of undocumented immigrants are uninsured, compared to eight percent of citizens. Importantly, noncitizen children are more likely to be uninsured than citizen children. With federal constraints in place limiting undocumented immigrants from accessing marketplace coverage without a waiver, it is important for states to consider taking action to expand access to high-quality and affordable health insurance coverage for this currently uninsured population.

Approval of this application will not only expand access to comprehensive health insurance for the nearly 100,000 uninsured immigrants who are currently ineligible for Medicaid or marketplace coverage because of their immigration status in Washington State, but it is likely to increase enrollment of family members who may have different immigration statuses and are eligible for Medicaid or subsidized marketplace coverage as well.

The Center for Law and Social Policy (CLASP) appreciates the opportunity to provide comments on Washington State's Section 1332 Waiver Application (waiver). We write in **strong support of the waiver** as an important opportunity to improve health coverage for Washington State residents and improve health equity.

CLASP is a national, nonpartisan, nonprofit, anti-poverty organization that advocates for policies that advance economic and racial justice for people with low incomes. Established in 1969, CLASP works to develop legislation and regulations that eliminate poverty, tear down barriers arising from systemic racism, and create pathways to economic security. Racial equity is our core value and informs all aspects of our organizational culture and the way we think about and approach our policy, issue, and advocacy areas. Our comments draw upon the work of CLASP experts in the areas of immigration, health care, and anti-poverty policies.

As a national anti-poverty organization, we understand that poverty and lack of access to health care are inextricably bound together in the United States and that both are tied to systemic racism. We understand that our communities and economy depend on the labor of immigrant workers who too often receive modest pay and few to no benefits for their essential work. Immigrants have historically faced unique barriers to health care and are disproportionately more likely to be on the frontlines of the ongoing COVID-19 pandemic yet uninsured.¹ This combination creates a volatile situation for the health and wellbeing of immigrant families as well as for public health.

In Washington State today, many immigrants go without critical health care because they are structurally excluded from affordable health coverage. Over 100,000 of Washington's immigrant residents lack insurance today due to this systemic inequity.² Left with no recourse, many of these community members currently forgo

needed care until it becomes an emergency. As you know, without insurance, people are more likely to have poor health status, be hospitalized for preventable conditions and acute illnesses, and die prematurely.³ This results in a higher utilization of emergency care, resulting in higher overall cost burdens to hospitals and local jurisdictions. The barriers faced by immigrant families are further compounded by poverty. Despite immigrants representing approximately one-quarter of the total population of parents in Washington, they make up 68 percent of low-income parents of children ages 0-10 years who do not have a high school diploma.⁴

- The waiver would improve health equity, addressing one of the root causes of the disproportionate uninsurance rates and poorer health outcomes many of Washington's communities of color face today. As just one example, undocumented people in Washington are eleven times less likely to have health insurance than U.S. citizens.
- By increasing immigrant parents' access to health insurance, the waiver would also improve the health and well-being of their children, who are mostly U.S. citizens. Extensive research shows that children's health and development is negatively affected by their parents' untreated mental and physical health challenges.⁷
- The waiver would improve the broader individual insurance market by lowering premiums and reducing application barriers that prevent families from applying for coverage together.

We urge you to approve the waiver rapidly this summer. Washington's waiver aligns with the stated goal of Affordable Care Act Section 1332, "to pursue innovative strategies for providing residents with access to high

Research has repeatedly shown that clear language about what entities will—and just as crucially, will not—have access to their personal information is the key to immigrants actually utilizing health care services, from presenting at emergency rooms¹⁰ to telehealth use.¹¹ We look forward to federal confirmation of this assurance.

Low-income children's access to health care and mental health services will be improved. Making health coverage accessible and affordable to all of Washington's residents regardless of immigration status is essential to improving children's healthcare access more broadly. Research has long shown that low-income children already eligible for public insurance are more likely to be enrolled if their parents are also eligible for coverage, also known as the "welcome mat effect." This effect is found whether parents gain eligibility through state Medicaid expansion¹² or subsidized private coverage through the Marketplace. Finally, removing barriers to health care is critical to addressing the national youth mental health crisis. In Washington, over 56,000 children in immigrant families are impacted by barriers to mental health care. Therefore, we believe that improving health coverage for all Washington residents regardless of immigration status will have positive effects on the health and mental well-being of low-income children more generally.

Through the waiver and other state policy solutions, Washington will make significant progress toward meeting

Community Health Plan of Washington (CHPW) and Community Health Network of Washington (CHNW) strongly support Washington's Section 1332 Waiver Application draft. Since the Washington Health Benefit Exchange began in 2014, undocumented immigrants have had few opportunities for insurance coverage in our state. We eagerly await a time when they can have the same access to affordable insurance coverage that is available to individuals purchasing coverage through the Washington Health Benefit Exchange today.

Community Health Plan of Washington was formed by Washington's community health centers (CHCs) 30 years ago, specifically to serve individuals who were traditionally denied access to quality health coverage. CHNW, a network of 21 federally qualified health centers with over 190 clinics, serves as the primary care network for approximately 80 percent of CHPW's enrollees and is the governing body for CHPW. It is also a licensed insurance plan for Cascade Select, the state's public option, and one of the strongest advocates for the public option in our state. Community health centers serve everyone regardless of ability to pay and provide care regardless of immigration status. Providing an affordable path to comprehensive insurance coverage for individuals regardless of their immigration status will best enable their patients to receive the comprehensive care they may need, including specialty and other services not available in the CHC clinics.

We support the state's 1332 waiver application for several reasons, but primarily because it creates equity for our state's residents and helps reduce health disparities across communities. Undocumented immigrants struggle to access health coverage and, as a result, are denied needed care. Most undocumented immigrants face additional social barriers impacting their health. While community health centers provide affordable access to primary medical, dental, and behavioral health care, it is challenging for their uninsured patients to access needed specialty or hospital care. Allowing purchase of comprehensive coverage with the help of state-funded premium subsidies will allow for a more equitable system for all Washington residents. Mixed-status families will also be able to enroll in the same plans, allowing for more integrated and holistic delivery of care, and reducing administrative confusion and complexity.

Extending affordable coverage to this population benefits the broader population by improving the health of the communities, improving the risk pool, and lowering premiums. We appreciate the attention to privacy safeguards that will help this population feel more comfortable in sharing identifying information needed to

purchase coverage on the Exchange. Ensuring that people feel safe in the enrollment process and are trusting of the state's role in this program is a necessary condition to optimizing enrollment, increasing affordability, and improving population health. The CHCs are trusted community organizations that are well-suited to communicate with and support their patients in this process.

Community Health Network of Washington currently offers coverage in 18 counties through the state's public option, Cascade Select, and in 2023 CHPW will offer coverage through Cascade select in 20 counties in the state. We hope the state will leverage the unique value of Cascade Select as a vehicle to facilitate statewide coverage and improve affordability for this population and others.

Thank you for providing the opportunity to comment. CHPW and CHNW strongly support a Section 1332 Waiver as a means to advance access to affordable coverage for all Washingtonians.

Thank you for the opportunity to provide feedback on Washington State's application for a waiver under Section 1332 of the Affordable Care Act (ACA). We support the waiver, which would expand access to affordable health care plans through Washington's Healthplanfinder's website. The waiver seeks to expand access to an estimated 100,000 residents who are currently uninsured and ineligible to purchase plans through this website because their immigration status does not meet the federal immigration-related standard for enrollment.

The Center on Budget and Policy Priorities (CBPP) is a nonpartisan research and policy organization based in Washington, D.C. Founded in 1981, CBPP conducts research and analysis to inform public debates and policymakers about a range of budget, tax, and programmatic issues affecting individuals and families with low or moderate incomes. We have developed expertise in eligibility and enrollment policies and processes in programs, including affordable health coverage programs available through the ACA. Our staff work closely with state policymakers and advocates to provide research, analysis, and technical assistance in ACA policy design and implementation, and have deep knowledge of the policy options available to states to expand access to quality and affordable health coverage within the policy parameters of the ACA.

States and state exchanges were given authority under 1332 waivers "to pursue innovative strategies for providing residents with access to high quality, affordable health insurance while retaining the basic protections of the ACA." We recommend the Centers for Medicare and Medicaid Services approve Washington's waiver because it would leverage the Washington exchange's existing enrollment website and use state funds to expand access to high-quality, affordable health plans to a quarter of the state's uninsured population who are blocked from ACA enrollment and subsidies due to their immigration status.

Washington would use state funds to make coverage more affordable and is only seeking this waiver to allow people to purchase health plans through the existing website. The waiver would result in:

- Creating a single health plan enrollment platform for all residents, regardless of their immigration status, to apply for affordable health coverage. Having one system would allow outreach to be more effective because it can point all people without health insurance to one site for enrollment. This would be particularly helpful for families that include both people eligible for ACA coverage based on their immigration status and those who are not. Without this waiver, these families would have to enroll in plans through separate sites, creating greater burden and potentially resulting in confusion.
- Maximizing the Washington exchange's effectiveness by leveraging existing technology and processes rather than creating a separate system and processes, which would be duplicative and create more bureaucracy, expense, and burden on the state.
- A reduction in uncompensated care and the cost of health insurance premiums overall in the state because of additional enrollees who tend to be younger, healthier, and use health care services at lower-than-average rates.³

The waiver makes assurances to protect enrollee and participant data. We recommend that these privacy standards, and the guarantee that data will not be shared with the federal government, be included in the final waiver approval. These protections are essential to helping families that include immigrants feel safe enrolling in affordable health care programs.

Finally, the expanded access to coverage under the waiver is critical to helping Washington improve health equity and address the disproportionate rates of uninsurance and poor health outcomes among its residents of color. ⁴ For these reasons, we recommend that you review and approve Washington's waiver application as soon as possible.

Families USA, a leading national voice for health care consumers, is dedicated to the achievement of high-quality, affordable health care and improved health for all. We write to strongly support the State of Washington's 1332 waiver application and urge its approval. Washington's proposal would improve the availability of health care to all in the state. It is in the public interest and meets all federal requirements for a waiver.

The country has recognized the importance of making health care available to all in other health programs.

For example:

- The federal government provides COVID-19 vaccines regardless of status;
- COVID-19 provider relief funds defrayed the cost of COVID-19 care regardless of status;
- The Medicaid program covers treatment of an emergency condition regardless of status, sharing costs between the federal government and states;
- Safety net clinics and hospitals can care for immigrants regardless of status, and receive federal support.

Washington's proposal builds on these past initiatives and is within the scope of federal administrative authority.

The proposal is in the public interest.

Washington proposes to invest state funds towards providing more affordable coverage for low-income residents, regardless of documentation status. This will promote the health not only of the people newly served, but also of the population at large. It builds on important lessons the country learned during the pandemic.

Undocumented workers are among those in essential jobs, including farm work and public-facing labor. An estimated 74 percent of undocumented workers nationally are "essential infrastructure workers," meeting health, food, safety, and other needs of all Americans. In Washington State, an estimated 149,000 essential workers were undocumented in 2018. As we learned during the pandemic, these jobs put people at increased risk for exposure to disease. However, these jobs are among those least likely to provide offers of employer-sponsored health coverage. Nationally, 42% of nonelderly undocumented immigrants are uninsured.

Maintaining health is important not only to individuals and their families, but also to the nation's economy and to public health. We applied Washington for undertaking this enormous improvement.

The proposal meets all federal requirements for a waiver.

Washington proposes to invest state funds towards providing more affordable coverage for low-income residents, with no impact to the federal deficit. It proposes to waive only Section 1312(f)(3) of the law. The law concerning state innovation waivers is explicit that this section of the Patient Protection and Affordable Care Act can be waived, since it comes under Part II of Subtitle D.

Washington's waiver application meets the federal guardrails under Section 1332:

- There is no change in the comprehensiveness of coverage it would provide;
- Protections against out-of-pocket spending are at least as affordable as those otherwise
 provided in marketplace plans (and in fact will be more affordable since the state will be
 contributing to subsidies);
- Coverage will be provided to at least a comparable number of residents; and
- The proposal will not increase the federal deficit since the state is fully defraying new costs, procuring some plans at lower expected costs, and enrolling a population expected to improve the risk pool. Actuarial modeling furnished as part of the waiver proposal predicts premium savings in the individual market and for the federal government.

We applaud the waiver's privacy assurances.

The waiver appropriately specifies that individual information about applicants and enrollees covered via the waiver will not be shared with the federal government. We look forward to federal confirmation of this assurance.

For all of reasons stated above, we recommend expeditious approval of Washington's request.

We work with community and migrant health centers, farmworker community-based organizations, and advocates across the country to promote farmworkers' access to health care.

Farmworkers are essential members of our rural communities and important drivers of our economy. During the height of the COVID-19 pandemic, farmworkers continued to labor in the fields and packing plants while many of us sheltered at home, ensuring the stability of our country's food supply chain. As a result, farmworkers were disproportionately impacted by the pandemic.

In Washington State today, many farmworkers go without health care because they are structurally excluded from affordable health coverage due to their lack of immigration status. As highlighted during the pandemic, farmworkers experience numerous barriers to health care access, with lack of immigration status and lack of health insurance among the top. According to FJ's analysis of the 2018 National Agricultural Workers Survey, only 16% of unauthorized farmworkers in the North West region (which includes Washington State) have health insurance. Only a small percentage of agricultural employers offer comprehensive health insurance to their workers and unauthorized workers are less likely to report that their employer offered health insurance than authorized workers. Due to these barriers, they tend to have poor health outcomes, delaying medical care until there is an emergency.

Therefore, we strongly support Washington's proposed waiver because it offers a pathway to a healthier future for farmworkers and other low-income immigrant communities:

- The waiver would allow Washington State to remove federal barriers to health coverage, offering all Washington residents the same opportunity to purchase Qualified Health Plans and Qualified Dental Plans.
- The waiver would also permit Washington State to invest state funds toward more affordable coverage for low-income residents, with no impact to the federal deficit.
- The waiver would improve health equity, addressing one of the root causes of the disproportionate uninsurance rates and poorer health outcomes many of Washington's communities of color face today.³
- The waiver would improve the broader individual insurance market by lowering premiums and reducing application barriers that prevent families from applying for coverage together.

Kitsap Immigrant Assistance Center (KIAC) appreciates the opportunity to provide comments on Washington State's Section 1332 Waiver Application (waiver). We write in strong support of the waiver as one of the most promising opportunities to improve health coverage for Washington State residents since the passage of the Affordable Care Act.

We are a non-profit in Bremerton, WA serving immigrants in Kitsap and Mason counties and throughout the west Puget Sound region of Washington state. We provide numerous direct, needed services through our Immigration Legal Services and Family Services programs. A substantial part of our work is dedicated to coordinating and providing healthcare for uninsured immigrant adults - members of our community who have no way of purchasing or qualifying for medical insurance. These adults sometimes utilize our local hospital's emergency room as their primary source of care, only going when absolutely necessary. Often people suffer pain and uncertainty at home for hours, days, or weeks out of fear of the cost of the emergency room. Our local community health clinic has a sliding scale that many adults benefit from; this sliding scale policy means that many adults are able to seek care who would otherwise have their conditions worsen and likely would die sooner. However, this sliding-scale model is not enough. This clinic cannot provide all necessary services, and their sliding scale still involves cost to a patient that may be beyond their means. Our free medical clinic, staffed by qualified volunteer Providers, helps fill this gap. We are able to offer consultations and prescribe some medication. We are also connected to Project Access NW, the Lions Club Charity Vision Care program, and a local dentist who all offer services for free to uninsured, low-income adults. This combination of partners eating the cost of the care they provide saves lives. But it is piecemeal and not enough. People are still living with undiagnosed and untreated diabetes, eye diseases, gynecological issues, cancer, and other chronic and acute conditions. These are the parents of our elementary school students, the entrepreneurs providing essential services to our economy, and our neighbors. We need a health insurance option for all members of our communities, regardless of immigration status.

We know hundreds of immigrant families within our nearby communities alone whose lives would be changed by this waiver's approval. We spoke with one uninsured client last week to give her news of her breast cancer. While we will help coordinate treatment for her through charity care providers, we know that her cancer would have been detected sooner if she had medical insurance, and we have yet to find out the consequence of that delay. We have also seen multiple immigrant community members in pain and in need of root canals, but there is no charity care option in our area for that procedure, so they continue in discomfort or sacrifice rent and grocery money and go into debt to cover it themselves. Our children need healthy parents, our economy needs healthy workers, and our communities need healthy residents. We know the human impact this policy decision will enable, and it is foundational to health and flourishing for many of our neighbors.

Our expertise in the law as it relates to gender equity and our direct involvement with the community grounds our conclusion that the waiver is essential to guaranteeing healthcare equity in Washington.

Over 100,000 of Washington's immigrant residents lack insurance today due to this systemic inequity. Left with no recourse, many of these community members currently forgo needed care until it becomes an emergency. As you know, without insurance, people are more likely to have poor health status, be hospitalized for preventable conditions and acute illnesses, and die prematurely.

The gap in health coverage is particularly wide for immigrant women¹ of reproductive age (15-44). It is well documented that young women fleeing extreme violence in their home countries experience extremely high rates of sexual assault on their journey to the United States. Indeed, up to 80% of

women are raped while in transit.² That those same women are denied the health coverage they urgently need when they arrive in the United States only compounds that trauma.

The National Immigration Law Center (NILC) appreciates the opportunity to provide comments on Washington State's Section 1332 Waiver Application (waiver). We write in strong support of the waiver as both one of the most promising opportunities to improve health coverage for Washington State residents since the passage of the Affordable Care Act.

Founded in 1979, NILC is an organization exclusively dedicated to defending and advancing the rights and opportunities of low-income immigrants and their families. We believe that all people should have the opportunity to achieve their full human potential – regardless of their race, gender, immigration, and/or economic status. For over 40 years, NILC has focused on issues that affect the well-being and economic security of low-income immigrants: health care and safety net programs; education and training; workers' rights; and other federal and state policies. When necessary, NILC has successfully defended the fundamental and constitutional rights of low-income immigrants and their families in litigation. NILC is one of the nation's leading substantive experts on immigrant eligibility and access to federal and state public benefits programs, including issues related to Medicaid and the Affordable Care Act.

This Waiver Aligns with the Administration's Priorities

Immigrants' exclusion from healthcare affordability programs exacerbates racial health disparities. According to American Community Survey data 22% of Asians, 8% of Black people and 25% of Hispanics residing in Washington are non-citizens¹. President Biden has made important commitments to addressing racial disparities, including through Executive Order 13985, Advancing Racial Equity and Support for Underserved Communities Through the Federal Government which committed to "recognize and work to redress inequities in their policies and programs that serve as barriers to equal opportunity." Executive Order 14070, Continuing to Strengthen Americans' Access to Affordable, Quality Health Coverage says that it is the policy of this administration, "make high-quality healthcare accessible and affordable for every American." This waiver sits at the intersection of those two priorities, addressing racial health disparities for a population disproportionately denied health insurance.

In Washington State today, many immigrants go without critical health care because they are ineligible for affordable health coverage. As a nonprofit legal organization that works to protect and expand individuals' access to affordable quality health care, NoHLA has advocated to improve health coverage for all Washingtonians for over two decades. Together with local legislative champions, other advocates, and community partners, we have worked step-by-step through the years to secure coverage for all Washington residents, regardless of immigration status. We supported strengthening of the state's Basic Health Plan, a pre-ACA coverage expansion for low-income Washingtonians that was available to all residents. SEIU Healthcare 1199NW appreciates the opportunity to comment on the State of Washington's application for a Section 1332 State Innovation Waiver and on behalf of

the over 33,000 health care workers of our union, we write in strong support.

Equity in healthcare is critical to the health of our communities, which is why our union is committed to rooting out systemic racism in healthcare delivery. That includes racial inequities we see firsthand created by barriers to accessing affordable health insurance. When our patients lack coverage, they put off preventative care, decompensate and ultimately enter our health care system sicker with preventable conditions. The costs to our State and nation's healthcare system are immense, but the costs to patients and families is immeasurable.

Inequitable access to affordable healthcare prevents a significant number of Washingtonians from accessing coverage and care. In a survey of 5,700 Washington State immigrants, the 2020 WA State Health Equity for Immigrants report found 87% lacked health insurance. Immigration status (67%) and high cost (47%) were cited as the top two barriers. A significant number also reported foregoing care for fear of existing federal "public charge" rules. Today, many in Washington's immigrant population are living in fear of seeking healthcare or are denied access to affordable care due to immigration status. This kind of exclusion is a continuation of systemic racism in health care delivery, imposing medical vulnerability on tens of thousands of Washingtonians. Our union supports this Waiver to help undo this racially unjust dynamic.

The proposed Waiver will significantly lower barriers to Washingtonians' affordable healthcare access by removing the immigration-status exemption to Qualified Health Plan (QHP) coverage. Per Washington State's Waiver

Application, 22% of uninsured Washingtonians are barred from QHP coverage on WA's State Exchange due to federal citizenship limitations. By securing the Section 1322 Waiver, our State can finally address this major health inequity.

Section 1322 Waivers exist to address exactly these kinds of systemic exclusions that put patients' and communities' health at risk by allowing States to "pursue innovative strategies for providing residents with access to high quality care and affordable health insurance while retaining the basic protections of the ACA." The Waiver is good for payers, good for patients and good for our healthcare system.



Immigrants and communities of color are disproportionately contracting, hospitalized for, and dying from COVID-19.⁵ Washington residents cannot wait for coverage any longer.

Through the waiver and additional state policy solutions, Washington will make significant progress toward meeting the basic health care needs of all Washingtonians, which will make every community healthier. We strongly support Washington State's effort to secure the federal flexibility needed to achieve this goal and respectfully ask that you expeditiously review and approve Washington's 1332 waiver application.

Dear Secretaries Becerra and Yellen:

The American Federation of Labor and Congress of Industrial Organizations (AFL-CIO) writes in support of Washington State's 1332 waiver application. The AFL-CIO is a voluntary, democratic federation of 57 affiliated unions representing more than 12.5 million workers across the country in all sectors of our economy. Our members work in every state in the union and they come from every region of the world. We represent working people with all types of immigration status, including undocumented workers, DACA and TPS holders, non-immigrant visa beneficiaries, legal permanent residents, refugees, and citizens. The AFL-CIO is committed to fairness in the workplace and health security for working people and their families.

We believe that Washington State's proposed section 1332 waiver is one of the most important opportunities to improve health care coverage for state residents since the passage of the Affordable Care Act. The waiver would allow Washington State to promote public health and close racialized inequities by removing federal barriers to health coverage so that all Washington residents will have the same opportunity to purchase Qualified Health Plans and Qualified Dental Plans. The waiver would also permit Washington State to invest state funds toward more affordable coverage for low-income residents, with no impact to the federal deficit. These are the types of measures envisioned by section 1332 and we hope that Washington State's waiver gains the Administration's quick approval.

Impact on Washington State

In Washington State today, many immigrants go without critical health care. Of the approximately 240,000 undocumented immigrants in the state, an estimated 46% lack health insurance – almost eight times the uninsured rate in the state overall. These inequities undermine public health, drive up healthcare costs for all, and create racialized injustices that must be addressed.

The vast majority of people without coverage are part of working families. According to the Kaiser Family Foundation, approximately 7 in 10 people without coverage have at least one person in their family who is working full-time and another 1 in 10 have someone in their family working part-time. As the state of Washington noted in its waiver application, immigrants are overrepresented in low-wage jobs that are unlikely to offer employer-sponsored health insurance. For many of these working families, this waiver is the only path forward for affordable health insurance.

The impact on working families of not having insurance can be devastating to their health, and to the broader community. As we saw with COVID-19, many individuals without insurance feel compelled to report to work, regardless of health status. Without access to care, they undermine efforts to build healthy communities. Without access to insurance, many community members have no alternative but to forgo preventive care and services for major health conditions. When they do receive care, they are more likely to receive an initial diagnosis in the advanced stages of a disease. They are also more likely to die or suffer permanent impairment after an accident or the onset of an acute condition. They are more likely than people with insurance to live with a chronic condition that could be managed if it had been diagnosed earlier.²

There are also economic consequences. People without insurance are more likely to face unaffordable medical bills when they do seek care. A study in 2019 found that uninsured nonelderly adults were over twice as likely as those with private coverage to have had problems paying medical bills in the past 12 months. These bills can quickly translate into significant medical debt since most of the uninsured have low or moderate incomes and have little, if any, savings. ³ Thus, access to health care not only improves the health of working families, it also improves their financial security.

We strongly support Washington's proposed waiver because it offers a pathway to a healthier future for a medically and financially vulnerable population, which will benefit everyone who lives and works in the state. By addressing a major cause of health inequity, the waiver addresses a root cause of the disproportionate uninsurance rates and poorer health outcomes many of Washington's communities of color face today. The waiver would also improve the broader

individual insurance market by lowering premiums and reducing application barriers that prevent families from applying for coverage together.

The Affordable Care Act (ACA) was successful in reducing the cost and removing some of the major obstacles preventing millions of working families from getting coverage. Following the ACA, the number of uninsured nonelderly Americans declined by 20 million, dropping to a historic low in 2016. States such as Washington have partnered with the federal government, to expand community outreach and publicize opportunities for enrollment. But structural barriers that exclude certain populations mean the state is unlikely to significantly reduce the number of uninsured until additional steps are undertaken to remove those barriers. This waiver will support efforts to close inequities in health and financial security based on immigration status are likely to continue.

Importance of this Waiver

The Affordable Care Act was a major milestone in the effort to bring universal health care to working families. Yet, it was decades in the making. The reality of politics today is that it takes a significant amount of time and good fortune to pass sweeping federal legislation. A key element is building support, both among the public and policymakers. In our federal system, state waivers are an important means for testing innovative strategies for improving health care access and outcomes. As Justice Louis Brandeis famously noted, states are the laboratories of experimentation in our democracy. Indeed, the ACA created section 1332 waivers to allow states to take the initiative to address gaps in our health care system without undermining the bold advances of the statute.

Washington's waiver will improve the health of its citizens and its health system by ending the cruel discrimination against working people who are relatively new immigrants to this country. Public programs that provide access to basic needs like health care are crucial tools to support the well-being of our entire society. As noted earlier, this waiver will not only remove a real barrier that prevents immigrant families from accessing vital health services, it will also improve the health of the broader population.

The waiver is aligned with the analysis and recommendations of the White House's COVID-19 Health Equity Task Force, which sought to ensure that everyone have equitable access to high-quality health care. As the Task Force noted, such access is critical for enabling people to live their healthiest, fullest lives and that all communities can thrive and flourish. Action is necessary, the Task Force Final Report notes, if we are to ensure that the disproportionate suffering of communities of color and underserved populations during the COVID-19 pandemic is a thing of the past, not part of a repeated pattern for the future. Though the Task Force was not focused on section 1332 waivers, it laid out relevant principles, saying that immigration status should never stand in the way of equitable health. As the Task Force wrote in its final report, there is "an opportunity to disrupt the patterns of harm, offer correction and transform equitable systems, structures, practices and processes." The current limitations on eligibility for subsidies and access to the state's public option are the kind of racialized limitations that the Task Force urged us to address.⁴

Conclusion

As the current pandemic has shown us, no worker is truly safe when other workers lack access to affordable health care. Yet, despite our best efforts, many gaps in coverage remain, elevating the risks for our entire workforce. This waiver seeks to fill a glaring and unacceptable gap. America's unions urge the Administration to approve the waiver and encourage other states to pursue similar efforts to broaden coverage.

The AFL-CIO is committed to protecting all workers, regardless of immigration status — ensuring that we all can access the many essential aspects of our health care system, including not only the necessary testing and treatment of disease, but also preventive care and services. Having the health care we need, no matter who we are and regardless of our circumstances in life, is fundamental to the well-being of individuals, families and the nation.

Today, millions of working families across the country are being denied access to healthcare. We must show that we value the vital contributions of all workers and their families by ensuring equal access to something as fundamental as affordable health care. We urge the Biden Administration to approve this waiver as a signal of support to workers and a model for other states that are seeking to build inclusive public systems.

Community Catalyst appreciates the opportunity to provide comments on Washington State's Section 1332 Waiver Application. We write in **strong support of the waiver** as one of the most promising opportunities to expand health coverage for Washington State residents since the passage of the Affordable Care Act.

Community Catalyst is a leading non-profit national health advocacy organization dedicated to advancing a movement for health equity and justice. We partner with local, state, and national advocates to leverage and build power so all people can influence decisions that affect their health. Health systems will not be accountable to people without a fully engaged and organized community voice. We know that those most at risk under our current health system are people with intersecting marginalized identities and know that their active engagement and leadership are essential to a strong movement. As such, we strongly support Washington State's efforts to respond to the needs of people for whom affordable health coverage remains out of reach.

In Washington State today, many people go without critical health care because they are structurally excluded from affordable health coverage due to immigration status. Over 100,000 of Washington's immigrant residents lack insurance today due to this systemic inequity. Left with no recourse, many community members who are immigrants currently forego needed care until it becomes an emergency. As you know, without insurance, people are more likely to have poor health status, be hospitalized for preventable conditions and acute illnesses, incur significant medical debt, and die prematurely.²

We strongly support Washington's proposed waiver because it offers a pathway to a healthier future:

- The waiver would allow Washington State to remove federal barriers to health coverage, offering all Washington residents the same opportunity to purchase Qualified Health Plans and Oualified Dental Plans.
- By permitting Washington State to invest state funds toward more affordable coverage for low-income residents, with no impact to the federal deficit, the waiver would represent a significant step toward addressing the needs of communities that face the highest cost barriers to care, including communities of color and members of Washington's 29 federally recognized tribes.
- The waiver would improve health equity, addressing one of the root causes of the disproportionate uninsurance rates and poorer health outcomes many of Washington's communities of color face today.³
- The waiver would improve the broader individual insurance market by lowering premiums and reducing application barriers that prevent families from applying for coverage together.

We urge you to approve the waiver rapidly this summer. Washington's waiver aligns with the stated goal of Affordable Care Act Section 1332, "to pursue innovative strategies for providing residents with access to high quality, affordable health insurance while retaining the basic protections of the ACA." As demonstrated in the application, the waiver satisfies Section 1332's guardrails while proposing an innovative state solution to expand coverage and improve affordability.

Moreover, Washington's waiver aligns with the stated priorities of the Biden administration and the Department of Health and Human Services aimed at protecting and strengthening equitable access to high quality and affordable health care. In particular, the proposed strategies in Washington's waiver are consistent with President Biden's recent executive orders⁵ directing federal agencies to identify policies that will strengthen and build upon the progress achieved by the ACA. By approving this waiver, HHS can continue its efforts to partner with states on developing innovative coverage options and make it easier for all consumers to enroll in and keep their coverage.

The undersigned members of the Consortium for Constituents with Disabilities (CCD) appreciate the opportunity to provide comments on Washington State's Section 1332 Waiver Application (the waiver). We write in strong support of the waiver as an important step to improve health coverage for Washington State residents, including people with disabilities and chronic health conditions.

CCD is the largest coalition of national organizations working together to advocate for Federal public policy that ensures the self-determination, independence, empowerment, integration and inclusion of children and adults with disabilities in all aspects of society free from racism, ableism, sexism, and xenophobia, as well as LGBTQ+ based discrimination and religious intolerance.

The Affordable Care Act Section 1332 waivers allow states "to pursue innovative strategies for providing residents with access to high quality, affordable health insurance while retaining the basic protections of the ACA." We believe Washington's waiver would accomplish this and is particularly timely to help address long-standing inequities in access to health care that have been exacerbated by the pandemic. Immigrants and communities of color, as well as people with disabilities and chronic health conditions, are disproportionately contracting, hospitalized for, and dying from COVID-19.

Nationwide, 5.6 percent of immigrant adults under age 65 have a disability, and 2.3 percent have multiple disabilities.² These rates are higher for people of color: 10.2 percent of nonelderly Black Latinx immigrants and 7.3 percent of non-Latinx Pacific Islander immigrants reported having a disability.³ Immigrants also have the highest

uninsured rate.⁴ In Washington state, more than 100,000 immigrant residents do not have health insurance.⁵ Among those uninsured are people with disabilities and chronic health conditions who are barred from accessing Medicaid, Medicare, and the Marketplace due to their immigration status, resulting in nearly 1 in 5 immigrants with disabilities being uninsured.⁶ Being uninsured makes healthcare unaffordable and inaccessible and, delays in accessing needed care are more likely to cause poor health outcomes, especially for people with disabilities.⁷

We strongly support the proposed waiver because it would remove a barrier to coverage for immigrants with disabilities and chronic health conditions who are Washington residents and enable access to treatment and services that are critical to their health and wellbeing. It would also simplify enrollment for families with mixed immigration statuses, allowing them to apply for coverage together. Moreover, we support this effort as helping to overcome the lingering chilling effect of the 2019 public charge rule by signaling to all immigrants that they can safely enroll in health coverage. We appreciate that the waiver application recognizes the importance of privacy and specifies that individual information about applicants and enrollees covered via the waiver will not be shared with the federal government. We urge the Administration to confirm this privacy protection in its waiver approval.

Thank you for the opportunity to submit federal comments on Washington's section 1332 waiver application.

The undersigned organizations represent millions of individuals facing serious, acute and chronic health conditions. We have a unique perspective on what individuals and families need to prevent disease, cure illness and manage chronic health conditions. The diversity of our organizations and the populations we serve enable us to draw upon a wealth of knowledge and expertise that is an invaluable resource as we work to find solutions to expand access to high-quality coverage. We urge the Department of the Treasury and the Department of Health and Human Services (Departments) to make the best use of the recommendations, knowledge and experience our organizations offer here.

Our organizations are committed to ensuring that any changes to the healthcare system achieve coverage that is adequate, affordable and accessible for patients and consumers. We therefore strongly support Washington's proposal to improve coverage for consumers via the Cascade Care program, and we urge the Departments to approve this waiver application.

Our organizations are pleased to see that Washington's waiver would moderately expand the number of people with coverage in the state as well as improve the affordability of that coverage. The state

estimates that individual market enrollment would increase by 1.4% and individual market premiums would decrease by more than 1.6% by 2028. These changes will benefit many patients and consumers directly, while fulfilling the statutory guardrails for scope of coverage and affordability.

Our organizations strongly support Washington's efforts to improve health equity by making affordable coverage available to all Washingtonians, regardless of immigration status. Waiving Section 1312(f)(c) of the Affordable Care Act removes a crucial barrier to coverage and allows more Washingtonians to access the care they need. This will enable more families with mixed immigration status to enroll in coverage together, and for uninsured individuals with no other options for health coverage to enroll in coverage as well. The state estimates these groups currently make up 29% of the uninsured population in Washington under 250% of the federal poverty level (FPL), meaning that this policy change has the potential to significantly improve access to coverage. The uninsured rate in Washington is higher for people of color, with Hispanic and Black residents disproportionately represented compared to white, non-Hispanic Washingtonians. By increasing enrollment in coverage among these underserved populations, the state expects to improve health equity and reduce racial disparities in coverage.

Our organizations support the use of pass-through funding to support Cascade Care Savings, the state subsidy program. The implementation of the Cascade Care Savings program is expected to expand financial assistance for Cascade Care plans for individuals with income below 250% of the FPL. This program will improve the affordability of coverage for individuals who already receive federal financial assistance as well as those newly eligible for coverage due to the eligibility changes discussed above who meet this income criteria. Our organizations support Washington's plans to expand financial assistance through the Cascade Care Savings program.

Our organizations support Washington's waiver application to expand access to quality, affordable coverage and urge the Departments to approve this proposal. Thank you for the opportunity to provide comments.

In Washington State today, many immigrants go without critical health care because they are structurally excluded from affordable health coverage. Over 100,000 of Washington's immigrants lack insurance today due to this systemic inequity. Left without other options, many of our community members forgo needed care until it becomes an emergency. Without insurance, people are more likely to have poor health status and outcomes, be hospitalized for preventable conditions and acute illnesses, and die prematurely and needlessly. ²

About International Community Health Services

Established in 1973, ICHS is a Federally Qualified Health Center (FQHC) that provides comprehensive, culturally and linguistically appropriate health and wellness services throughout King County. As an FQHC deeply rooted in the Asian Pacific Islander community, ICHS offers medical, dental, behavioral health, nutrition, Chinese traditional medicine, senior services, enabling services at four full-service and seven satellite sites, serving patients from across the wider Puget Sound region. We provide these services to everyone, regardless of their insurance status, ability to pay, or immigration status.

ICHS patients overwhelmingly belong to medically underserved communities. In 2021, 78 percent of our patients were Black, Indigenous, or People of Color (BIPOC), with 68 percent identifying as Asian American or Pacific Islanders. More than half of our patients (55 percent) speak a language other than English and need interpretation. Additionally, the majority of our patients are low-income, with 59 percent living at or below 200 percent of the Federal Poverty Level (FPL). About 4 percent of our patients were uninsured in 2021, down from 11 percent only two years ago in 2019. While ICHS does not track immigrant or refugee status, just under one in four people living in King County as a whole are foreign-born (23.7 percent). Our patients and our communities understand the fragility of health insurance access.

Approving Washington's Proposed Waiver Will Reduce Health Inequities, Improve Health Outcomes, and Improve the Individual Insurance Market in Our State with no Impact to Federal Spending.

Immigrants and communities of color are disproportionately contracting, being hospitalized, and dying from COVID-19. Washington residents cannot wait for expanded coverage any longer.

The waiver application also recognizes the importance of privacy to Washington residents who may seek coverage under the waiver. The waiver proposes to maintain state program integrity standards while safeguarding the privacy of individual Washington residents. The waiver appropriately specifies that individual information about applicants and enrollees covered via the waiver will not be shared with the federal government. We look forward to federal confirmation of this assurance.

Combat COVID-19 by Protecting Health Care Access

FQHCs have been working since the very beginning of the pandemic to test, treat, and conduct outreach in our communities. ICHS was the first FQHC in the country to treat a COVID-19-positive patient, in February 2020. Congress and two presidential administrations assigned FQHCs a central

role in combating COVID-19 among underserved populations, and FQHCs have provided millions of COVID-19 tests and vaccines throughout the pandemic. But our patients still face significant barriers to critical healthcare access, combined with the heightened resurgence of anti-Asian racism.

Fears about the safety of coming to our health center for testing or vaccines were compounded by previous fears for their physical safety for being Asian American and Pacific Islander (AAPIs) while seeking health care. Our patients and communities remained firmly in the grip of the COVID-19 pandemic, even before the many Omicron variants began sweeping the country this year. FQHCs have now lost the federal program for the testing, treatment, and vaccination of un- and underinsured individuals regardless of immigration status, which stopped accepting new claims months ago. Granting Washington State's waiver application is not only necessary to advance health equity; expanding health insurance access is essential for continuing to combat the COVID-19 pandemic.

Conclusion

Through the waiver and other state policy solutions, Washington will make significant progress toward meeting the basic health care needs of all our residents. This will make every community healthier and our national economy stronger. ICHS strongly supports Washington State's effort to secure the federal flexibility needed to achieve this goal and respectfully ask that you expeditiously review and approve Washington's 1332 waiver application.

who are ineligible for federal premium tax credits because of their immigration status – ensuring that all low-income residents will have access to more affordable coverage options.

The state's actuarial and economic analyses project that the Waiver Application would increase coverage among the uninsured, improve the individual market risk pool, lower premiums, and obtain federal funding for a state premium assistance program. In addition to increasing access to affordable coverage, the Waiver Application would also promote health equity by providing all eligible low-income residents, regardless of immigration status, access to health coverage and state affordability programs.

The Shriver Center on Poverty Law (Shriver Center) appreciates the opportunity to provide comments on Washington State's Section 1332 Waiver Application (waiver). We write in **strong support of the waiver** as one of the most promising opportunities to improve health coverage for Washington State residents since the passage of the Affordable Care Act.

The Shriver Center on Poverty Law advocates on behalf of hundreds of thousands of Illinoisans who are seeking affordable, comprehensive and quality healthcare coverage in Illinois. We have over 50 years of experience and expertise working with individuals, particularly those who are low income and people of color, who need access to coverage. Through our decades of work on behalf of and in partnership with low-income and immigrant communities in Illinois, we have developed deep expertise in access to healthcare and coverage, with a particular focus on Medicaid, Medicaid-like coverage, and ACA marketplace coverage. We also administer Help Hub, a training and technical assistance center for enrollment assisters working with consumers seeking healthcare coverage across the state of Illinois. Our expertise is enhanced through our work with organizations throughout the country on issues related to access to health coverage. We care deeply about everyone having access to affordable, comprehensive health insurance coverage, regardless of where you were born, and our work every day is in service of advancing this mission.

The Shriver Center also plays a leadership role in the Healthy Illinois Campaign which works in coalition with organizations across the state to win health coverage expansions for immigrants excluded by federal eligibility rules. Illinois funds several Medicaid-like coverage programs for immigrants:

- 1. VTTC program: which includes state-funded Medicaid for foreign-born victims of trafficking, torture, or other serious crimes, and their derivative family members.
- 2. Health Benefits for Immigrant Seniors (HBIS) program: for noncitizens age 65 and older who have an immigration status that makes them ineligible for traditional Medicaid; and
- 3. Health Benefits for Immigrant Adults (HBIA) program: for noncitizens aged 42-64 who have an immigration status that makes them ineligible for traditional Medicaid.

Over 15,000 immigrants now have health coverage through these programs, and more are enrolling every day. This experience is instructive for other states seeking to expand coverage. Expanding health coverage for immigrants has led to positive health and economic impacts for individuals, families and communities across our state and would do the same for Washington state:

- Coverage decreases risk of bankruptcy due to medical debt and excessive out-of-pocket spending. For instance, the average cost of hospital care for COVID-19 patients in Illinois without insurance or who receive out-of-network care varies from an average of \$54,574 (for noncomplex inpatient care) to \$277,078 (for complex inpatient care) according to cost analysis data from FAIR Health.
- Being uninsured delays care and testing, which in turn makes emergency room visits and hospitalizations unavoidable, <u>resulting in sky-rocketing uncompensated care costs</u> borne by Illinois safety net provider system.
- Being uninsured is associated with later stage disease detection, which in turn, creates multiple
 inefficiencies throughout the healthcare system; providing access to preventive screenings and
 early treatment corrects these inefficiencies, creating cost savings. For instance, a <u>Families USA</u>
 <u>Report</u> revealed that Washington state could have avoided 107,000 COVID-19-contractions by
 could have been prevented if all people were insured (data from January 22, 2020 through
 February 1, 2021.)
- Being uninsured disproportionately harms frontline essential workers who are not offered affordable employer-sponsored coverage, thereby harming larger economic productivity.
 Removing these barriers would provide lasting improvements in the economic and health security of essential workers, many of whom are immigrants, who do important work to keep our communities thriving.

Helping to advance pathways to affordable, comprehensive health coverage, as this waiver application seeks to do, would drive down Washington's uninsured rate for immigrant communities, producing lasting health and economic benefits.

In Washington State today, many immigrants go without critical health care because they are structurally excluded from affordable health coverage. Over 100,000 of Washington's immigrant residents lack insurance today due to this systemic inequity. Left with no recourse, many of these community members currently forgo needed care until it becomes an emergency. As you know, without insurance, people are more likely to have poor health status, be hospitalized for preventable conditions and acute illnesses, and die prematurely. ²

We strongly support Washington's proposed waiver because it offers a pathway to a healthier future:

- The waiver would allow Washington State to remove federal barriers to health coverage, offering all Washington residents the same opportunity to purchase Qualified Health Plans and Qualified Dental Plans.
- The waiver would also permit Washington State to invest state funds toward more affordable coverage for low-income residents, with no impact to the federal deficit.
- The waiver would improve health equity, addressing one of the root causes of the

Re: Strong Support from UnidosUS for Washington's 1332 Waiver Application

Dear Secretary Becerra and Secretary Yellen:

On behalf of UnidosUS (formerly the National Council of La Raza), I write to urge the Administration to fulfill its commitment to health equity by approving Washington State's 1332 waiver. This waiver addresses the systemic barrier of discrimination based on immigration status, which currently denies essential health coverage and care to more than 100,000 Washington residents. According to the most recent available Census Bureau data, 30% of Latino adults in Washington State were uninsured in 2020—significantly more than non-Hispanic White adults, only 7% of whom were uninsured.

Without asking for any new federal dollars, the waiver gives the Biden-Harris Administration a chance once again to demonstrate its commitment to addressing systemic inequities that have devastating consequences for America's immigrant communities, with a disproportionate impact on Latino families. An ever-increasing <u>evidentiary record</u> shows the fundamental importance of health coverage in protecting health status, combating chronic illness, preventing hospitalization, and lowering mortality rates.

UnidosUS is the nation's largest Hispanic civil rights and advocacy organization. For more than 50 years, UnidosUS has built a stronger country by creating opportunities for Latinos. Through its unique combination of expert research, advocacy, programs, and an Affiliate Network of nearly 300 community-based organizations across the United States and Puerto Rico, UnidosUS simultaneously challenges social, economic, and political barriers at the national, state, and local levels.

The proposed waiver would let the Biden-Harris Administration make another important down payment on its commitment to health equity, building on its recent approval of Colorado's 1332 waiver. Washington State's waiver would promote health equity and basic fairness by offering all Washington residents an opportunity to purchase health and dental coverage, without discrimination based on status. It would allow Washington State to invest its own dollars to make health care more affordable for low-income immigrants, with no impact on the federal budget deficit.

Washington State's policy directly benefits children born in the U.S. While the <u>overwhelming</u> majority of <u>Latino children</u> are U.S. citizens (95%), nearly half live in families with at least one immigrant parent. Evidence shows that when parents obtain health coverage, <u>children are far more likely to enroll</u>. In addition, parental health coverage reduces parents' likelihood of <u>severe psychological distress</u>, which in turn makes <u>children less likely to develop mental health problems</u>. When undocumented immigrant parents obtain health care, their U.S.-born children realize significant gains.

More broadly, Washington State's proposed waiver fits evolving policies in multiple states to lower barriers that single out immigrants for coverage denial. Despite the ongoing pandemic, recent years have seen Illinois, California, and other states make great progress in expanding coverage for undocumented residents.

This issue is vital to the Latino community. <u>Two-thirds</u> of undocumented immigrants come from Mexico, Central America, and South America. Make no mistake: the undocumented immigrant families whom Washington State's waiver would help are part of the American community:

- Two thirds of undocumented immigrants have lived in the U.S. for <u>more than 10 years</u>, and 80% have been here for more than five years.
- The <u>majority</u> of undocumented immigrants speak English well or very well; 96% of those age 16 and older are either employed or outside the labor force because of such factors as full-time school attendance or full-time caretaking for minor children and other dependents; and nearly a third (28%) are homeowners, despite pervasive barriers to that important avenue for accumulating intergenerational wealth.
- In families with undocumented immigrants, <u>42% of all family members are U.S. citizens</u>—most often, children
- According to the <u>National Academy of Sciences</u> (NAS), "immigration is integral to the nation's economic growth. Immigration supplies workers who have helped the United States to avoid the problems facing stagnant economies created by unfavorable demographics—in particular, an aging ... workforce." NAS went on to add that "immigrants' children—the second generation—are among the strongest economic and fiscal contributors in the population."
- <u>Each year, undocumented workers pay</u> \$79.7 billion in federal taxes and \$41 billion in state and local taxes. In addition, payroll taxes from their employers provide \$17 billion in annual revenue for Social Security and \$4 billion for Medicaid.
- Compared to U.S. citizens, immigrants are <u>less likely to commit crime</u> and more likely to <u>start new businesses</u>, including <u>small</u>, <u>locally-owned companies</u>.

During the worst months of the COVID-19 pandemic, nearly 3 in 4 undocumented workers had jobs classified as "vital for the continuity of public health and safety" by the Department of Homeland Security. Throughout the pandemic, these workers have made sure food was grown and reached America's grocery-store shelves; cared for America's sick; brought packages to the front doors of countless American homes; and kept America's critical infrastructure operational, including energy and telecommunications.

The discriminatory denial of health care based on immigration status abandons Latino workers—and many others who also made tremendous contributions to our country during one of its darkest hours—at

the precise moment they need the broader community's help. Washington State policymakers are willing to put their own money on the line to overcome this longstanding inequity, and we are confident you will not stand in their way.

Approving the proposed waiver would follow through on President Biden's executive orders that ask each federal agency to reverse "policies or practices that may present <u>unnecessary barriers to individuals and families attempting to access Medicaid or ACA coverage</u>" and to remove obstacles to benefit receipt that disproportionately affect "<u>underserved communities and individuals</u>." The latter order notes that "entrenched disparities in our laws and public policies ... have often denied ... equal opportunity to individuals and communities," concluding that "our Nation deserves an ambitious whole-of-government equity agenda that matches the scale of the opportunities and challenges that we face." Approving Washington State's proposed 1332 waiver is an essential part of that equity agenda.

In closing, I would like to highlight one feature of the proposed waiver that illustrates how immigrants strengthen our country. The actuarial analysis supporting the waiver shows that, because the waiver's immigrant beneficiaries are healthier than current marketplace participants and generate fewer average health care costs, premiums market-wide will drop once additional immigrants join the insurance pool, benefiting everyone who buys their own insurance through the ACA marketplace. Tearing down barriers to immigrant participation will put money in the pockets of people whose ancestors came over on the Mayflower, people whose ancestors lived in Washington State long before the arrival of Europeans, and the 77% of immigrants who are naturalized citizens or lawful permanent residents. Including Latinos and other immigrants improves America's health programs and promotes the prosperity of all who live within our country's borders. We look forward to your rapid approval of this crucial step toward health equity.

The Washington State Hospital Association (WSHA) appreciates this opportunity to comment in support of Washington's Section 1332 Waiver Application to improve access to affordable health coverage for more Washington residents. WSHA supports the goals of the Section 1332 Waiver Application to allow all Washingtonians, regardless of income and immigration status, to purchase Qualified Health Plans (QHPs) and Qualified Dental Plans (QDPs) through the state-based marketplace, Washington Healthplanfinder.

WSHA serves all hospitals in Washington. We aim to be the trusted voice and indispensable resource that leads, challenges, and assists hospitals and health systems to improve the health of the communities they serve. Equity is one of WSHA's organizational values.

We support the waiver because it is projected to increase coverage among the uninsured, improve the individual market risk pool, lower premiums, and draw down additional federal funding to support the state's premium assistance program – all without impacting the federal deficit. Most importantly, the waiver will also help address persistent health disparities exacerbated by lack of access to care.

This waiver will increase access to health care to those who have lacked coverage options. The waiver creates a new enrollment pathway for 22% of currently uninsured Washington residents, bringing us ever-closer to the goal of universal health insurance coverage.

Hospitals are particularly pleased that this waiver is projected to increase access to primary and preventive care, as well as treatment for chronic disease, reducing preventable hospitalizations. Coverage will also reduce the amount of uncompensated care in Washington by allowing those without another coverage pathway to enroll in a QHP or QDP. Robust health insurance coverage is a crucial component of access to high quality health care.

Expeditious federal approval of this Section 1332 Waiver application is needed to ensure system updates and comprehensive community engagement and outreach efforts can be completed in advance of Plan Year 2024 Open Enrollment, beginning Nov. 1, 2023.

We, the undersigned members of the Washington State Legislature, appreciate this opportunity to express our strong support of Washington's Section 1332 Waiver Application, and urge your rapid approval so that we may continue our work to improve access to affordable health coverage for more Washington residents.

Over 100,000 uninsured Washington residents (nearly a quarter of the state's uninsured population) are unable to purchase coverage through the state-based marketplace, *Washington Healthplanfinder*, due to federal restrictions. Washington's waiver will newly allow these Washingtonians to obtain health and dental coverage, an action which is broadly supported at the state level (demonstrated most recently by the hundreds of supportive, cross-sector, comments received during the state public comment period).

Approval of the waiver will advance efforts the Legislature has taken to help ensure all Washingtonians can obtain high-quality health coverage. By decreasing the number of uninsured, addressing health disparities, strengthening the individual market, and improving health care affordability, this waiver also takes an important step forward in addressing health equity.

Washington state has been a leader in maximally leveraging federal opportunities and implementing innovative solutions at the state level to increase access, improve quality, and reduce the number of Washington residents who lack coverage. These efforts include: expanding Medicaid, establishing a state-based marketplace, implementing Cascade Care (standard plans and the first-in-nation public option program), and funding state-based premium subsidies. The state appreciates the flexibility provided through this waiver, which will address a critical gap in our ability to provide health care coverage to the maximum number of Washingtonians.

We are committed to the success of this waiver and have provided funding to support its implementation, informed by community-based engagement, and expand state premium subsidies to those newly eligible for coverage. The Seattle Labor Chorus appreciates the opportunity to provide comments on Washington State's Section 1332 Waiver Application (waiver). We write in **strong support of the waiver** as one of the most promising opportunities to improve health coverage for Washington State residents since the passage of the Affordable Care Act.

The Seattle Labor Chorus is a community chorus in Seattle. We support the rights of working people and making sure all workers, including immigrants, have health equity and access to healthcare is certainly part of that mission.

We strongly support Washington's proposed waiver because it offers a pathway to a healthier future:

- The waiver would improve health equity, addressing one of the root causes of the disproportionate uninsurance rates and poorer health outcomes many of Washington's communities of color face today.
- The waiver would allow Washington State to remove federal barriers to health coverage, offering all Washington residents the same opportunity to purchase Qualified Health Plans and Qualified Dental Plans.
- The waiver would also permit Washington State to invest state funds toward more affordable coverage for low-income residents, with no impact to the federal deficit.
- The waiver would improve the broader individual insurance market by lowering premiums and reducing application barriers that prevent families from applying for coverage together.

In Washington State today, many immigrants go without critical health care because they are structurally excluded from affordable health coverage. Over 100,000 of Washington's immigrant residents lack insurance today due to this systemic inequity. Left with no recourse, many of these community members currently forego needed care until it becomes an emergency. As you know,

without insurance, people are more likely to have poor health status, be hospitalized for preventable conditions and acute illnesses, and die prematurely.

We urge you to approve the waiver rapidly this summer. Washington's waiver aligns with the stated goal of Affordable Care Act Section 1332, "to pursue innovative strategies for providing residents with access to high quality, affordable health insurance while retaining the basic protections of the ACA." As demonstrated in the application, the waiver satisfies Section 1332's guardrails while proposing an innovative state solution to increase coverage. This is particularly crucial and time-sensitive now, as long-standing inequities have been exacerbated by the pandemic. Immigrants and communities of color are disproportionately contracting, hospitalized for, and dying from COVID-19. Washington residents cannot wait for coverage any longer.

We applaud the waiver's privacy assurances. The waiver application recognizes the importance of privacy to Washington residents who may seek coverage under the waiver. The waiver proposes to maintain state program integrity standards while safeguarding the privacy of individual Washington residents. The waiver appropriately specifies that individual information about applicants and enrollees covered via the waiver will not be shared with the federal government. We look forward to federal confirmation of this assurance.

Through the waiver and other state policy solutions, Washington will make significant progress toward meeting the basic health care needs of all Washingtonians, which will make every community healthier and our national economy stronger. We strongly support Washington State's effort to secure the federal flexibility needed to achieve this goal and respectfully ask that you expeditiously review and approve Washington's 1332 waiver application.
