**SUBJECT:** Notice of Accountable Care Organizations (ACOs) Participating in Performance Year 2024 of the ACO REACH Model

The Center for Medicare and Medicaid Innovation is announcing that 122 accountable care organizations (ACOs) are participating in Performance Year 2024 (PY2024) of the ACO REACH Model (see Table 5 for list of ACOs). These ACOs will serve Medicare beneficiaries in all 50 states as well as in the District of Columbia.

The ACO REACH Model is a redesign of the Global and Professional Direct Contracting (GPDC) Model, which began its first performance year on April 1, 2021. ACOs participating in the Model are expected to offer high-quality, coordinated care to their patients. The purpose of the ACO REACH Model is to encourage health care providers to coordinate care to improve health outcomes for people with Medicare. The model tests how health care providers can be incentivized to collaborate across multiple treatment plans, spend more time with patients with complex, chronic conditions and ultimately, improve patient health outcomes. We expect patients will be empowered to engage in their health care with support from organizations that help them navigate the complex health care system.

Participants in the ACO REACH Model may elect from one of two risk options, Global risk (100% risk for shared savings/losses), and Professional (50% risk for shared savings/losses). For PY2024, 103 ACOs elected Global risk and 19 chose Professional risk.

The Innovation Center also conducts a separate, independent evaluation of the GPDC and ACO REACH Model. The evaluation results for PY2023 are expected to become available in mid-to-late 2024.
