

# Expanded Home Health Value-Based Purchasing (HHVBP) Model

### **HHVBP Model Highlights**

#### **The Interim Performance Report**

The first quarterly Preliminary Interim Performance Report (IPR) in Calendar Year (CY) 2024 became available on February 8, 2024. The quarterly IPRs provide HHAs with their cohort assignment, performance year measure data for the 12 most recent months, and an interim Total Performance Score (TPS). The IPR allows an HHA to review feedback and performance within the respective cohort for the expanded Model performance year. An HHA will receive 2024 quarterly IPRs if the HHA:

- Was Medicare-certified prior to January 1, 2022, and
- Meets the minimum threshold of data for at least one quality measure in the quarterly reporting period for the performance year.

Requirements for the upcoming April 2024 IPR are shown in **Table 1.**

IPRs are available via Internet Quality Improvement Evaluation System (iQIES) in the "HHA Provider Preview Reports" folder organized by the CMS Certification Number (CCN) assigned to each HHA. If your organization has more than one CCN, then a report will be available for each CCN. Only iQIES users authorized to view their HHA's reports can access expanded HHVBP Model reports.





### Introduction to the PAC Training Team

Beginning in 2024, training for the HHVBP Model will be provided by the Post-Acute Care (PAC) Training Team. The PAC Training Team delivers training to providers in home health agencies (HHAs), inpatient rehabilitation facilities (IRFs), long-term care hospitals (LTCHs), skilled nursing facilities (SNFs), and hospices to assist with the collection and coding of standardized patient assessment data elements. The PAC Training Team has produced a diverse group of training products to assist PAC providers in understanding and succeeding with the Quality Reporting Programs. In addition to this quarterly newsletter, the PAC Training Team will be releasing training resources specific to HHVBP later this year.

## **HHVBP Interim Performance Reports**

**Two versions of the quarterly IPRs include:** Preliminary IPR and Final IPR. The Preliminary IPR provides an HHA with an opportunity to submit a recalculation request for applicable measures and interim performance scores if the agency believes there is evidence of a discrepancy in the calculation. If an HHA disagrees with the calculation of the performance scores in the **Preliminary IPR,** the agency may submit a recalculation request within 15 calendar days after publication of the **Preliminary IPR.** The recalculation request period for the January 2024 IPR closed on February 23, 2024. The Final IPR will reflect any changes resulting from an approved recalculation request. All HHAs will receive a **Final IPR** even if the HHA did not submit a recalculation request. The **Final January 2024 IPR** is expected to be released on or after **March 21, 2024.**

Please note, the recalculation request does not apply to errors in data submission since submission requirements for the expanded Model align with the current Code of Federal Regulations (CFR).

### Looking Ahead in 2024

Home health agencies should mark their calendars for 2024. In addition to the quarterly IPRs, CMS will be releasing the Annual Performance Report (APR) and public reporting is planned to begin.





### Discharge Function Score Measure

Assessing the functional status of home health patients provides insight into the quality of care offered by agencies, while also highlighting the potential positive impact of home health care on functional outcomes. The Discharge (DC) Function Score measure evaluates each agency's success in achieving or surpassing expected levels of patient functional ability upon discharge, tailored to individual agency expectations based on patient characteristics.

# **Quality Measures Impacting HHVBP**

The 2024 HHVBP Final Rule identified updates to the measure weights for larger-volume and smallervolume cohorts starting with the Model's third performance year, CY 2025. HHA performance for the CY 2025 applicable measure set will determine payment adjustments that will apply to CY 2027 Medicare fee-for-service (FFS) claims. The Model baseline year for the CY 2025 performance year is CY 2023 for all measures except Discharge to Community-Post Acute Care (DTC–PAC). For the DTC–PAC measure, the Model baseline year is CY 2022 and CY 2023. The changes in quality measures that impact HHVBP are identified in **Table 2** below.

Note: If an HHA is missing all measures from one measure category, the weights for the remaining two measure categories are redistributed so that the proportional contribution remains consistent with the original weights. These redistributed measure categories sum to 100% of the HHA's TPS. An HHA receives a TPS if the HHA had sufficient data to calculate baseline and performance year data for at least five quality measures.

### **Advancing Agency Achievement**

#### **Spotlight on New Measures**

Beginning in CY 2025, the HHVBP measure set will replace the TNC measures with the Discharge (DC) Function measure. The OASIS items included in the DC Function Score include:

- Self-Care GG0130 (3 items)
- Mobility GG0170 (8 items)

To prepare agencies for this change, tips for accurate GG coding will be highlighted in upcoming newsletters!



\* The Discharge Function Score measure is calculated using 10 items. GG0170R. Wheel 50 Feet with 2 Turns is only used to calculate the total observed discharge function score for stays where (i) GG0170I. Walk 10 Feet has an activity not attempted code or is dashed, skipped or missing at both admission and discharge, and (ii) either GG0170R. Wheel 50 Feet with 2 Turns or GG0170S. Wheel 150 Feet has a code between 1 and 6 at either admission or discharge.
