# 1 - Introduction

Since the submission of the *STATS CY 2008 Outpatient Therapy Utilization Report (Utilization Report)* on June 4, 2010, we have further analyzed: 1) geographic variations in the therapy caps, 2) use of individual therapy HCPCS at the claim line, 3) use of therapy HCPCS per date of service, and 4) payment ranges per date of service by therapy discipline and by provider setting/professional specialty<sup>1</sup>. This *Addendum* to the *Utilization Report* provides such detailed information in data table format.

The data analysis methodology is identical to that described in Section 2 of the *STATS Utilization Report* and will not be described here. In addition, the data tables associated with this *Addendum* provide only additional detail to the tables included in the *Utilization Report* and for the most part do not require any narrative descriptions of findings or conclusions. In the limited situations where data presented in the data tables contained within this *Addendum* requires descriptive analysis, such summary analysis is presented in the *STATS Project Report*. The Project Report then references this document as appropriate.

There are five sets of data tables presented in this *Addendum* as separate attachments. The attached files are provided in print formatted Microsoft Excel and in Section 508 accessibility compliant comma separated values (.csv) format per CMS requirements. Each file format contains identical information. The following sections provide a brief description of the contents of the attached Excel data table files. The Appendix to this document provides an index that maps the Excel filename and worksheet name to the corresponding .csv filename.

## 2 - CY 2008\_Cap\_County

This Excel file contains a single worksheet that corresponds to the outpatient therapy cap impact analysis presented in section 4 of the *STATS Utilization Report*. While the tables presented in the *Utilization Report* described the geographic impact of the PT/SLP combined cap and the separate OT cap (Section 4.4), this data table breaks down the geographic detail further and presents the PT/SLP and OT cap impact by Federal Information Processing Standard (FIPS) county code.

Each row of the data table identifies the following variables: state, county, Core Based Statistical Area (CBSA), Total OT Users, OT Users over Cap, PT/SLP Users, PT/SLP Users over Cap, Percent of OT Users over Cap, and Percent of PT/SLP Users Over Cap.

## 3 - CY 2008\_HCPCS\_Units per Claim Line\_Professional

This Excel file contains 26 worksheets that correspond to the HCPCS utilization analysis presented in section 3.5 of the *STATS Utilization Report*. While the tables presented in the *Utilization Report* described HCPCS utilization in the aggregate (total utilization per HCPCS code), these tables further break down HCPCS utilization to the detail of units per claim line. This Excel file is specific to HCPCS codes billed by professional offices (PTPP, OTTP, Physician, and NPP) and identifies HCPCS use by therapy discipline (PT, OT, SLP, or All combined).

Each row of the data tables identifies the following variables: HCPCS Code, HCPCS Units per Line, Number of Claim Lines, Total Allowed, Total Paid, Mean Allowed per Line, and Mean Paid per Line.

#### **4 - CY 2008\_HCPCS\_Units per Claim Line\_Provider**

This Excel file contains 24 worksheets that correspond to the HCPCS utilization analysis presented in section 3.5 of the STATS *Utilization Report*. While the tables presented in the *Utilization Report* described HCPCS utilization in the aggregate (total utilization per HCPCS code), these tables further break down HCPCS utilization to the detail of units per claim line. This Excel file is specific to HCPCS codes billed by provider facilities (Hospital, SNF, CORF, ORF, and HHA) and identifies HCPCS use by therapy discipline (PT, OT, SLP, or All combined).

Each row of the data tables identifies the following variables: HCPCS Code, HCPCS Units per Line, Number of Claim Lines, Total Allowed, Total Paid, Mean Allowed per Line, and Mean Paid per Line.

#### **5 - CY 2008\_HCPCS\_Units per Day\_by Discipline\_by Setting**

This Excel file contains 6 worksheets that correspond to the HCPCS utilization analysis presented in section 3.5 of the STATS *Utilization Report*. While the tables presented in the *Utilization Report* described HCPCS utilization in the aggregate (total utilization per HCPCS code), these data tables further break down HCPCS utilization to the detail of units per date of service. When HCPCS codes are billed (timed or untimed), the total number of units billed is counted (e.g. 1 unit of untimed code 97001 and 2 units of timed code 97110 would be reported as 3 units in these tables). This Excel file identifies HCPCS code units billed per day by therapy discipline (PT, OT, SLP, or All combined). Different worksheets provide the number of dates of service and the percentage of dates of service that have the specified number of HCPCS units (from 1-10+ units). Additional worksheet graphs are provided in the Excel file to present a visual representation of the HCPCS unit patterns by professional office/provider setting.

Each row of the data tables identifies the following variables: HCPCS Units per Date, Hospital, SNF, CORF, ORF, HHA, PTPP, OTTP, Physician, and NPP.

#### **6 - CY 2008\_Paid per Day\_by Discipline\_by Setting**

This Excel file contains 3 worksheets that correspond to the HCPCS utilization analysis presented in section 3.4 of the STATS *Utilization Report*. While the tables presented in the *Utilization Report* described outpatient therapy payment distribution percentiles by provider setting, professional office specialty, and by therapy discipline in the annual aggregate (annual per-beneficiary) utilization, these data tables further break down the detail to the level of per-beneficiary payments per date of service. The worksheets are identified by PT, OT or SLP services and the percentile patterns are presented for each provider setting and professional office specialty.

Each row of the data tables identifies the following variables: Percentile, Hospital, SNF, CORF, ORF, HHA, PTPP, OTTP, Physician, and NPP.
