

MDS 3.0 Care Area Assessment Trigger Test Data Documentation (v1.02.0)

12/15/2015

With the v1.02.0 Care Area Trigger (CAT) package, test data are provided for all 20 Care Areas updated for changes to the MDS 3.0 Item Set to be implemented in October 2016. The current package contains a series of 20 test files that were fabricated to allow thorough testing of Care Area Trigger (CAT) computer code for Care Areas 01 through 20. These test files have a “txt” extension and are in ASCII text format in the MDS 3.0 standard Fixed Format File Layout provided in the MDS 3.0 data specifications for October 2016. The file name for a test data file indicates the CAT being tested. For CAT 01, the test data file is named “CAT01_test_v2.txt”; for CAT 02, the test data file is named “CAT02_test_v3.txt”; “CAT03_test_v1.txt”; etc.

In the test file for a specific CAT, most MDS 3.0 items have been left blank. Only the MDS items needed for Care Area triggering and the correct Care Area trigger indicator have been populated in each record. For example for Care Area 01 (Delirium), the test data file has populated values for MDS items included in the triggering logic (C1310A-C1310D) and the correct triggering indicator (V0200A01A). For Care Area 03 (Visual Function), the test data file has populated values for MDS items included in the triggering logic (B1000 and I6500) and the correct triggering indicator (V0200A03A).

The specific MDS items used to trigger each Care Area can be found in three places.

- First, a list of the triggering items for a Care Area are provided in an “Items Used” table in the description for each CAT in the specifications document (“MDS 3_0 CAT Specifications 1_02_0 (12-15-2015).pdf”).
- Second, Table 2 at the end of this document provides a consolidated list of all MDS 3.0 items used for CAT triggering with the CAT(s) for each item indicated. This table also indicates the start and end bytes in the MDS 3.0 standard Fixed Format File Layout for each item.
- Third, Table 2 below has been converted to a comma delimited file with a “csv” extension for easier use by programmers. This file is named “MDS 3.0 Items in the CAT Test Data Files 1_02_0.csv”.

Table 1 below gives a list of the test data files with the number of records in each.

Table 2 provides a consolidated list of all MDS 3.0 items used for CAT triggering. This table gives the item label, description, length, valid values, Care Assessment Areas using the item for triggering, and the start and end bytes in the MDS 3.0 standard Fixed Format File Layout for October 2016.
