# April 13, 2018

#### **Alpha 2 SPADE Summary Report**

CMS has contracted with the RAND Corporation to develop standardized patient assessment data elements to meet the requirements of the IMPACT Act, Section 2(a). As part of its data element development process, RAND conducted a pilot test of candidate items to assess several of the following clinical categories delineated in the IMPACT Act: (1) cognitive function and mental status; (2) special services, treatments, and interventions; (3) medical conditions and comorbidities; (4) impairments; and (5) other categories. Conducted between April 2017 and July 2017, the test was the second of two Alpha tests used to assess the feasibility of candidate items. Like the Alpha 1 pilot test, the results of this small-scale feasibility test informed the design of the national Beta test. The Alpha 2 summary report entitled, Alpha 2 SPADE Summary Report, is posted in the Downloads and Videos page.

# **OASIS Field Test Summary Report**

The OASIS Field Test Summary report is now available on the Outcome and Assessment Information Set (OASIS) web page and the IMPACT Act Downloads and Videos web page. This report summarizes the findings from a comprehensive field test of existing and potential new OASIS items, and a feasibility test of the Patient Reported Outcomes Measurement Information System® (PROMIS®)10 item Global health survey (v1.1) with home health patients. Twelve Medicare-certified home health agencies were recruited to participate as clinical

sites and data were collected between 2016-2017. Findings support reliability and validity of OASIS items, and demonstrate feasibility of the PROMIS Global health survey in home health.
