1. Purpose: Each Weather Forecast Office (WFO) is responsible for a Hydrologic Service Area (HSA). These areas are typically the same as the County Warning and Forecast Areas (CWA) however, there are some differences. The purpose of this supplement is to provide detailed descriptions of the HSAs for each WFO and to cite where there are differences between the HSA and CWA. Each WFO is responsible for communicating these differences to emergency managers to ensure they know from which WFO they will receive river forecasts and warnings.
2. Description of Hydrologic Service Areas: In Central Region, most WFO HSAs align with their respective CWAs. Where rivers form the county line and border between two adjacent CWAs, that stretch of river is assigned to one of those WFO’s HSAs as noted in the HSA descriptions that follow. Where HSA and CWAs have minor differences, a reference to the other CWA is noted. The few minor differences that exist are justified hydrologically (e.g., a WFO has an entire river in their CWA except for a small portion at the mouth of the river, which is retained in their HSA). Forecast and warning products for points or reaches of a river are provided for the HSA while hydrologic products for counties or portions of counties are provided for the CWA.

Aberdeen, SD (ABR)

Rivers in or touching the following 26 South Dakota counties: Brown, Buffalo, Campbell, Clark, Codington, Corson, Day, Deuel, Dewey, Edmunds, Faulk, Grant, Hamlin, Hand, Hughes, Hyde, Jones, Lyman, Marshall, McPherson, Potter, Roberts, Spink, Stanley, Sully and Walworth.

Rivers in or touching the following two Minnesota counties: Big Stone and Traverse.

Excludes the White River flowing into Lake Francis Case/Missouri River in Jones and Lyman counties. That portion of the river is in Rapid City’s HSA.

Bismarck, ND (BIS)

Rivers in or touching the following 36 North Dakota counties: Adams, Billings, Bottineau, Bowman, Burke, Burleigh, Dickey, Divide, Dunn, Emmons, Foster, Golden Valley, Grant, Hettinger, Kidder, LaMoure, Logan, McHenry, McIntosh, McKenzie, McLean, Mercer, Morton, Mountrail, Oliver, Pierce, Renville, Rolette, Sheridan, Sioux, Slope, Stark, Stutsman, Ward, Wells, Williams.

Central Illinois (Lincoln) (ILX)

Rivers in or touching the following 35 Illinois counties: Cass, Champaign, Christian, Clark, Clay, Coles, Crawford, Cumberland, DeWitt, Douglas, Edgar, Effingham, Fulton, Jasper, Knox, Lawrence, Logan, Macon, Mason, Marshall, McLean, Menard, Morgan, Moultrie, Peoria, Piatt, Richland, Sangamon, Schuyler, Scott, Shelby, Stark, Tazewell, Vermilion and Woodford.

Includes:

- The Illinois River in Putnam & Bureau counties from Hennepin, IL, downstream to Marshall county line.
- The Vermilion River in Vermillion County, Indiana.

Excludes:

- The La Moine River along the Brown/Schuyler county line, which is in St. Louis' HSA.
- The Illinois River along the Brown/Cass, Brown/Morgan, Morgan/Pike and Pike/Scott county line, which is in St. Louis' HSA.
- The Wabash River along the Illinois/Indiana state line, which is in Indianapolis' HSA.

Cheyenne, WY (CYS)

Rivers in or touching the following 7 Wyoming counties: Albany, Carbon, Converse, Goshen, Laramie, Niobrara and Platte.

Rivers in or touching the following 8 Nebraska counties: Banner, Box Butte, Cheyenne, Dawes, Kimball, Morrill, Scotts Bluff and Sioux.

Chicago, IL (LOT)

Rivers in or touching the following 18 Illinois counties: Boone, Cook, De Kalb, Du Page, Ford, Grundy, Iroquois, Kane, Kankakee, Kendall, Lake, La Salle, Lee, Livingston, McHenry, Ogle, Will and Winnebago.

Rivers in or touching the following 5 Indiana counties: Benton, Jasper, Lake, Newton and Porter.

Includes the Illinois River in Putnam & Bureau counties from Hennepin, IL, upstream to La Salle county line.

Excludes:

- The Fox River upstream of Illinois State Route 173, which is in Milwaukee's HSA.
- The Rock River upstream of Prairie Hill Road, which is in Milwaukee's HSA.
- The Sugar River upstream of the confluence with the Pecatonica River, which is in Milwaukee's HSA.

Boulder/Denver, CO (BOU)

Rivers in or touching the following 22 Colorado counties: Adams, Arapahoe, Boulder, Broomfield, Clear Creek, Denver, Douglas, Elbert, Gilpin, Grand, Jackson, Jefferson, Larimer, Lincoln, Logan, Morgan, Park, Phillips, Sedgwick, Summit, Weld and Washington.

Des Moines, IA (DMX)

Rivers in or touching the following 51 Iowa counties: Adair, Adams, Appanoose, Audubon, Black Hawk, Boone, Bremer, Butler, Calhoun, Carroll, Cass, Cerro Gordo, Clarke, Crawford, Dallas, Davis, Decatur, Emmet, Franklin, Greene, Grundy, Guthrie, Hamilton, Hancock, Hardin, Humboldt, Jasper, Kossuth, Lucas, Madison, Mahaska, Marion, Marshall, Monroe, Palo, Alto, Pocahontas, Polk, Poweshiek, Ringgold, Sac, Story, Tama, Taylor, Union, Wapello, Warren, Wayne, Webster, Winnebago, Worth and Wright.

Includes the Shell Rock River in northwest and southern Floyd County, which is in La Crosse's CWA.

Detroit, MI (DTX)

Rivers in or touching the following 17 Michigan counties: Bay, Genesee, Huron, Lapeer, Lenawee, Livingston, Macomb, Midland, Monroe, Oakland, Saginaw, Sanilac, Shiawassee, St. Clair, Tuscola, Washtenaw and Wayne.

Dodge City, KS (DCC)

Rivers in or touching the following 27 Kansas counties: Barber, Clark, Comanche, Edwards, Ellis, Finney, Ford, Grant, Gray, Hamilton, Haskell, Hodgeman, Kearny, Kiowa, Lane, Meade, Morton, Ness, Pawnee, Pratt, Rush, Scott, Seward, Stafford, Stanton, Stevens and Trego.

Duluth, MN (DLH)

Rivers in or touching the following 10 Minnesota counties: Aitkin, Carlton, Cass, Cook, Crow Wing, Itasca, Koochiching, Lake, Pine and St. Louis.

Rivers in or touching the following 8 Wisconsin counties: Ashland, Bayfield, Burnett, Douglas, Iron, Price, Sawyer and Washburn.

Includes the Montreal River along the Wisconsin/Michigan state line.

Eastern North Dakota (Grand Forks) (FGF)

Rivers in or touching the following 17 North Dakota counties: Barnes, Benson, Cass, Cavalier, Eddy, Grand Forks, Griggs, Nelson, Pembina, Ramsey, Ransom, Richland, Sargent, Steele, Towner, Traill and Walsh.

Rivers in or touching the following 18 Minnesota counties: Becker, Beltrami, Clay, Clearwater, Grant, Hubbard, Kittson, Lake of the Woods, Mahnomon, Marshall, Norman, Otter Tail, Pennington, Polk, Red Lake, Roseau, Wadena and Wilkin.

Goodland, KS (GLD)

Rivers in or touching the following 13 Kansas counties: Cheyenne, Decatur, Gove, Graham, Greeley, Logan, Norton, Rawlins, Sheridan, Sherman, Thomas, Wallace and Wichita.

Rivers in or touching the following 3 Nebraska counties: Dundy, Hitchcock and Red Willow.

Rivers in or touching the following 3 Colorado counties: Cheyenne, Kit Carson and Yuma.

Grand Junction, CO (GJT)

Rivers in or touching the following 18 Colorado counties: Archuleta, Delta, Dolores, Eagle, Garfield, Gunnison, Hinsdale, La Plata, Mesa, Moffat, Montezuma, Montrose, Ouray, Pitkin, Rio Blanco, Routt, San Juan and San Miguel.

Rivers in or touching the following 4 Utah counties: Daggett, Grand, San Juan and Uintah.

Excludes:

- Rivers in or touching the Glen Canyon National Recreation Area of San Juan County, UT. That portion of the river is in Salt Lake City's HSA of Western Region.
- The Green River in or touching the City of Green River, UT, which is in Salt Lake City's HSA.

Grand Rapids, MI (GRR)

Rivers in or touching the following 23 Michigan counties: Allegan, Barry, Calhoun, Clare, Clinton, Eaton, Gratiot, Ingham, Ionia, Isabella, Jackson, Kalamazoo, Kent, Lake, Mason, Mecosta, Montcalm, Muskegon, Newaygo, Oceana, Osceola, Ottawa and Van Buren.

Green Bay, WI (GRB)

Rivers in or touching the following 22 Wisconsin counties: Brown, Calumet, Door, Florence, Forest, Kewaunee, Langlade, Lincoln, Manitowoc, Marathon, Marinette, Menominee, Oconto, Oneida, Outagamie, Portage, Shawano, Vilas, Waupaca, Waushara, Winnebago and Wood.

Includes the Brule and Menominee Rivers along the Michigan/Wisconsin state line.

Hastings, NE (GID)

Rivers in or touching the following 24 Nebraska counties: Adams, Buffalo, Clay, Dawson, Fillmore, Franklin, Furnas, Greeley, Gosper, Hall, Hamilton, Harlan, Howard, Kearney, Merrick, Nance, Nuckolls, Phelps, Polk, Sherman, Thayer, Valley, Webster and York.

Rivers in or touching the following 6 Kansas counties: Jewell, Mitchell, Osborne, Phillips, Rooks and Smith.

Excludes the Platte River along the Polk/Platte county line, which is in Omaha's HSA.

Indianapolis, IN (IND)

Rivers in or touching the following 39 Indiana counties: Bartholomew, Boone, Brown, Carroll, Clay, Clinton, Daviess, Decatur, Delaware, Fountain, Greene, Hamilton, Hancock, Hendricks, Henry, Howard, Jackson, Jennings, Johnson, Knox, Lawrence, Madison, Marion, Martin, Montgomery, Monroe, Morgan, Owen, Parke, Putnam, Randolph, Rush, Shelby, Sullivan, Tippecanoe, Tipton, Vermillion, Vigo and Warren.

Includes:

- The Muscatatuck River along the Jennings/Scott, Jackson/Scott, Jackson/Washington and Washington/Lawrence county lines.
- The Wabash River along the Indiana/Illinois state line down to and including Mount Carmel.
- The Tippecanoe River along the White/Carroll county line.
- The White River along the Knox/Pike and Knox/Gibson county line.
- The East Fork of the White River along the Martin/Dubois, the Daviess/Dubois and Daviess/Pike county lines.

Jackson, KY (JKL)

Rivers in or touching the following 33 Kentucky counties: Bath, Bell, Breathitt, Clay, Elliott, Estill, Fleming, Floyd, Harlan, Jackson, Johnson, Knott, Knox, Laurel, Lee, Leslie, Letcher, Magoffin, Martin, McCreary, Menifee, Montgomery, Morgan, Owsley, Perry, Pike, Powell, Pulaski, Rockcastle, Rowan, Wayne, Whitley and Wolfe.

Excludes the Tug Fork and the Big Sandy rivers along the Kentucky/West Virginia state line, which is in the WFO Charleston, WV HSA of Eastern Region.

Kansas City, MO (Pleasant Hill) (EAX)

Rivers in or touching the following 7 Kansas counties: Atchison, Doniphan, Johnson, Leavenworth, Linn, Miami and Wyandotte.

Rivers in or touching the following 37 Missouri counties: Adair, Andrew, Atchison, Bates, Buchanan, Caldwell, Carroll, Cass, Chariton, Clay, Clinton, Cooper, Daviess, De Kalb, Gentry, Grundy, Harrison, Henry, Holt, Howard, Jackson, Johnson, Lafayette, Linn, Livingston, Macon, Mercer, Nodaway, Pettis, Platte, Putnam, Randolph, Ray, Saline, Schuyler, Sullivan and Worth. Excludes the Missouri main stem along the Nebraska/Missouri state line, which is in Omaha's HSA.

La Crosse, WI (ARX)

Rivers in or touching the following 13 Wisconsin counties: Adams, Buffalo, Clark, Crawford, Grant, Jackson, Juneau, La Crosse, Monroe, Richland, Taylor, Trempealeau and Vernon.

Rivers in or touching the following 8 Iowa counties: Allamakee, Chickasaw, Clayton, Fayette, Floyd, Howard, Mitchell and Winneshiek.

Rivers in or touching the following 7 Minnesota counties: Dodge, Fillmore, Houston, Mower, Olmsted, Wabasha and Winona.

Includes:

- The Wisconsin River along the Richland/Iowa county line in Wisconsin.
- The Mississippi River from Lake City, MN, to Guttenberg, IA.

Excludes:

- The Chippewa River along the Buffalo/Pepin County line in Wisconsin, which is Minneapolis' HSA.
- The Shell Rock River in northwest and southern Floyd County, IA. That portion of the river is in Des Moines' HSA.
- The Eau Claire River in western Clark and Taylor Counties in Wisconsin. That portion of the river is in Minneapolis' HSA.
- The North Branch Middle Fork Zumbro River in northern Dodge County, MN and the Middle Fork Zumbro River in northwest Olmsted County, MN. Those portions of the rivers are in Minneapolis' HSA.

Louisville, KY (LMK)

Rivers in or touching the following 49 Kentucky counties: Adair, Allen, Anderson, Barren, Bourbon, Boyle, Breckenridge, Bullitt, Butler, Casey, Clark, Clinton, Cumberland, Edmonson, Fayette, Franklin, Garrard, Grayson, Green, Hancock, Hardin, Harrison, Hart, Henry, Jefferson, Jessamine, Larue, Lincoln, Logan, Madison, Marion, Meade, Mercer, Metcalfe, Monroe, Nelson, Nicholas, Ohio, Oldham, Russell, Scott, Shelby, Simpson, Spencer, Taylor, Trimble, Warren, Washington and Woodford.

Rivers in or touching the following 10 Indiana counties: Clark, Crawford, Dubois, Floyd, Harrison, Jefferson, Orange, Perry, Scott and Washington.

Includes:

- The Ohio River from the Carroll/Trimble county line to the Hancock/Daviess county line in Kentucky.
- The Licking River along the Harrison/Bracken, Harrison/Robertson, Robertson/Nicholas and Nicholas/Fleming county lines.
- The Kentucky River along the Owen/Henry county line.
- The Mud River along the Muhlenberg/Butler county line.
- The Anderson River along the Perry/Spencer county line.

Excludes:

- The Muscatatuck River along the Jennings/Scott, Jackson/Scott, Jackson/Washington and Washington/Lawrence county lines which is in Indianapolis' HSA.
- The East Fork of the White River along the Martin/Dubois and Daviess/Dubois county lines in Indiana which is in Indianapolis' HSA.

Marquette, MI (MQT)

Rivers in or touching the following 13 Michigan counties: Alger, Baraga, Delta, Dickinson, Gogebic, Houghton, Iron, Keweenaw, Luce, Marquette, Menominee, Ontonagon and Schoolcraft.

Excludes:

- The Brule and Menominee Rivers along the Michigan/Wisconsin state line, which is in Green Bay's HSA.
- The Montreal River along the Michigan/Wisconsin state line, which is in Duluth's HSA.

Milwaukee, WI (Sullivan) (MKX)

Rivers in or touching the following 20 Wisconsin counties: Columbia, Dane, Dodge, Fond du Lac, Green, Green Lake, Iowa, Jefferson, Kenosha, Lafayette, Marquette, Milwaukee, Ozaukee, Racine, Rock, Sauk, Sheboygan, Walworth, Washington and Waukesha.

Includes:

- The Fox River upstream of Illinois State Route 173 in Lake County, Illinois. Lake County is in Chicago's CWA.
- The Rock River upstream of Prairie Hill Road in Winnebago County, Illinois. Winnebago County is in Chicago's CWA.
- The Sugar River upstream of the Pecatonica River in Winnebago County, Illinois. Winnebago County is in Chicago's CWA.

Excludes the Wisconsin River along the Richland/Iowa county line, which is in La Crosse's HSA.

Minneapolis, MN (MPX)

Rivers in or touching the following 42 Minnesota counties: Anoka, Benton, Blue Earth, Brown, Carver, Chippewa, Chisago, Dakota, Douglas, Faribault, Freeborn, Goodhue, Hennepin, Isanti, Kanabec, Kandiyohi, Lac Qui Parle, Le Sueur, Martin, McLeod, Meeker, Mille Lacs, Morrison, Nicollet, Pope, Ramsey, Redwood, Renville, Rice, Scott, Sherburne, Sibley, Stearns, Steele, Stevens, Swift, Todd, Waseca, Washington, Watonwan, Wright and Yellow Medicine.

Rivers in or touching the following 9 Wisconsin counties: Barron, Chippewa, Dunn, Eau Claire, Pepin, Pierce, Polk, Rusk and St. Croix.

Includes:

- The Mississippi River to above Lake City, MN.
- The North Branch Middle Fork Zumbro River in northern Dodge County, MN and the Middle Fork Zumbro River in northwest Olmsted County, MN. Dodge and Olmsted counties are in La Crosse's CWA.
- The Chippewa River along the Pepin/Buffalo Wisconsin county line.
- The Eau Claire River in western Clark and Taylor counties in Wisconsin. Clark and Taylor counties are in La Crosse's CWA.

North Central Lower Michigan (Gaylord) (APX)

Rivers in or touching the following 25 Michigan counties: Alcona, Alpena, Antrim, Arenac, Benzie, Charlevoix, Cheboygan, Chippewa, Crawford, Emmet, Gladwin, Grand Traverse, Iosco, Kalkaska, Leelanau, Mackinac, Manistee, Missaukee, Montmorency, Ogemaw, Oscoda, Otsego, Presque Isle, Roscommon and Wexford.

North Platte, NE (LBF)

Rivers in or touching the following 26 Nebraska counties: Arthur, Blaine, Boyd, Brown, Chase, Cherry, Custer, Deuel, Frontier, Garden, Garfield, Grant, Hayes, Holt, Hooker, Keith, Keya Paha, Lincoln, Logan, Loup, McPherson, Perkins, Rock, Sheridan, Thomas and Wheeler.

Northern Indiana (North Webster) (IWX)

Rivers in or touching the following 24 Indiana Counties: Adams, Allen, Blackford, Cass, DeKalb, Elkhart, Fulton, Grant, Huntington, Jay, Kosciusko, LaGrange, LaPorte, Marshall, Miami, Noble, Pulaski, St. Joseph, Starke, Steuben, Wabash, Wells, White and Whitley.

Rivers in or touching the following 5 Michigan Counties: Berrien, Branch, Cass, Hillsdale and St. Joseph.

Rivers in or touching the following 8 Ohio Counties: Allen, Defiance, Fulton, Henry, Paulding, Putnam, Van Wert and Williams.

Omaha, NE (OAX)

Rivers in or touching the following 30 Nebraska counties: Antelope, Boone, Burt, Butler, Cass, Cedar, Colfax, Cuming, Dodge, Douglas, Gage, Jefferson, Johnson, Knox, Lancaster, Madison, Nemaha, Otoe, Pawnee, Pierce, Platte, Richardson, Saline, Sarpy, Saunders, Seward, Stanton, Thurston, Washington and Wayne.

Rivers in or touching the following 8 Iowa counties: Fremont, Harrison, Mills, Monona, Montgomery, Page, Pottawattamie and Shelby.

Includes:

- The Missouri River along the Nebraska/Missouri state line to the Woodbury/Monona, IA, county line.
- The Platte River along the Polk/Platte county line.

Paducah, KY (PAH)

Rivers in or touching the following 11 Missouri counties: Bollinger, Butler, Cape Girardeau, Carter, Mississippi, New Madrid, Perry, Ripley, Scott, Stoddard and Wayne.

Rivers in or touching the following 19 Illinois counties: Alexander, Edwards, Franklin, Gallatin, Hamilton, Hardin, Jackson, Jefferson, Johnson, Massac, Perry, Pope, Pulaski, Saline, Union, Wabash, Wayne, White and Williamson.

Rivers in or touching the following 22 Kentucky counties: Ballard, Caldwell, Callaway, Carlisle, Marshall, McCracken, McLean, Muhlenberg, Todd, Trigg, Union and Webster.

Rivers in or touching the following 6 Indiana counties: Gibson, Pike, Posey, Spencer, Vanderburgh and Warrick.

Includes:

- The Mississippi River from below Chester, IL, to New Madrid, MO.
- The Ohio River from the Hancock/Daviess Kentucky county line to the mouth of the Ohio River.

Excludes:

- The Mud River along the Muhlenberg/Butler, KY county line, which is in Louisville's HSA.
- The Wabash River along the Illinois/Indiana state line down to Mount Carmel, IN, which is in Indianapolis' HSA.
- The White River along the Knox/Pike and Knox/Gibson Indiana county lines, which is in Indianapolis' HSA.
- The East Fork of the White River along the Daviess/Pike Indiana county line, which is in Indianapolis' HSA.

Pueblo, CO (PUB)

Rivers in or touching the following 21 counties in Colorado: Alamosa, Baca, Bent, Chaffee, Conejos, Costilla, Crowley, Custer, El Paso, Fremont, Huerfano, Kiowa, Lake, Las Animas, Mineral, Otero, Prowers, Pueblo, Rio Grande, Saguache and Teller.

Quad Cities (Davenport, IA) (DVN)

Rivers in or touching the following 13 Illinois counties: Bureau, Carroll, Hancock, Henderson, Henry, Jo Daviess, McDonough, Mercer, Putnam, Rock Island, Stephenson, Warren and Whiteside.

Rivers in or touching the following 21 Iowa counties: Benton, Buchanan, Cedar, Clinton, Delaware, Des Moines, Dubuque, Henry, Iowa, Jackson, Jefferson, Johnson, Jones, Keokuk, Lee, Linn, Louisa, Muscatine, Scott, Van Buren and Washington.

Rivers in or touching the following 2 Missouri counties: Clark and Scotland.

Includes:

- The Mississippi River from below Guttenberg, IA to Gregory Landing, MO.
- The Des Moines River along the Iowa/Missouri state line.

Excludes the Illinois River in and along the Putnam/Bureau county line.

Rapid City, SD (UNR)

Rivers in or touching the following 16 South Dakota counties: Bennett, Butte, Custer, Fall River, Haakon, Harding, Jackson, Lawrence, Meade, Mellette, Oglala Lakota, Pennington, Perkins, Todd, Tripp and Ziebach.

Rivers in or touching the following 3 Wyoming counties: Campbell, Crook and Weston.

Includes the White River from the Nebraska/South Dakota state line to the mouth of the river at Lake Francis Case/Missouri River as it flows through Jones and Lyman counties, SD. Jones and Lyman counties are in Aberdeen's CWA.

Riverton, WY (RIW)

Rivers in or touching the following 11 Wyoming counties: Big Horn, Fremont, Hot Springs, Johnson, Lincoln, Natrona, Park, Sublette, Sweetwater, Teton and Washakie.

Sioux Falls, SD (FSD)

Rivers in or touching the following 24 South Dakota counties: Aurora, Beadle, Bon Homme, Brookings, Brule, Charles Mix, Clay, Davison, Douglas, Gregory, Hanson, Hutchinson, Jerauld, Kingsbury, Lake, Lincoln, McCook, Miner, Minnehaha, Moody, Sanborn, Turner, Union and Yankton.

Rivers in or touching the following 11 Iowa counties: Buena Vista, Cherokee, Clay, Dickinson, Ida, Lyon, O'Brien, Osceola, Plymouth, Sioux and Woodbury.

Rivers in or touching the following 2 Nebraska counties: Dakota and Dixon.

Rivers in or touching the following 8 Minnesota counties: Cottonwood, Jackson, Lincoln, Lyon, Murray, Nobles, Pipestone and Rock.

Includes the Missouri River above the Woodbury/Monona, IA county line.

Springfield, MO (SGF)

Rivers in or touching the following 34 Missouri counties: Barry, Barton, Benton, Camden, Cedar, Christian, Dade, Dallas, Dent, Douglas, Greene, Hickory, Howell, Jasper, Laclede, Lawrence, Maries, McDonald, Miller, Morgan, Newton, Oregon, Ozark, Phelps, Polk, Pulaski, Shannon, St. Clair, Stone, Taney, Texas, Vernon, Webster and Wright.

Rivers in or touching the following 3 Kansas counties: Bourbon, Cherokee and Crawford.

St. Louis, MO (LSX)

Rivers in or touching the city of St. Louis, MO and the following 28 counties in Missouri: Audrain, Boone, Callaway, Cole, Crawford, Franklin, Gasconade, Iron, Jefferson, Knox, Lewis, Lincoln, Madison, Marion, Moniteau, Monroe, Montgomery, Osage, Pike, Ralls, Reynolds, Shelby, St. Charles, St. Francois, St. Louis, Ste. Genevieve, Warren and Washington.

Rivers in or touching the following 17 Illinois counties: Adams, Bond, Brown, Calhoun, Clinton, Fayette, Greene, Jersey, Macoupin, Madison, Marion, Monroe, Montgomery, Pike, Randolph, St. Clair and Washington.

Includes:

- The Mississippi River from below Gregory Landing, MO to and including Chester, IL.
- The Illinois River along the Brown/Cass, Brown/Morgan, Morgan/Pike, Pike/Scott county lines.
- The La Moine River along the Brown/Schuyler county line.

Topeka, KS (TOP)

Rivers in or touching the following 23 Kansas counties: Anderson, Brown, Clay, Cloud, Coffey, Dickinson, Douglas, Franklin, Geary, Jackson, Jefferson, Lyon, Marshall, Morris, Nemaha, Osage, Ottawa, Pottawatomie, Republic, Riley, Shawnee, Wabaunsee and Washington.

Includes the Solomon River to its mouth in the northeast corner of Saline County. Saline County is in Wichita's CWA.

Wichita, KS (ICT)

Rivers in or touching the following 26 Kansas counties: Allen, Barton, Butler, Chase, Chautauqua, Cowley, Elk, Ellsworth, Greenwood, Harper, Harvey, Kingman, Labette, Lincoln, Marion, McPherson, Montgomery, Neosho, Reno, Rice, Russell, Saline, Sedgwick, Sumner, Wilson and Woodson.

Excludes the mouth of the Solomon River in the northeast corner of Saline County. That portion of the river is in Topeka's HSA.

Other Regions

HSA responsibility for selected counties in some Central Region states has been assigned to field offices in other National Weather Service Regions.

These assignments are:

- Indiana counties (8) to Eastern Region WFO Cincinnati, OH (ILN) are: Dearborn, Fayette, Franklin, Ohio, Ripley, Switzerland, Union and Wayne.
- Kentucky counties (16) to Eastern Region WFO Cincinnati, OH (ILN) are: Boone, Bracken, Campbell, Carroll, Gallatin, Grant, Kenton, Lewis, Mason, Owen, Pendleton and Robertson; and to Eastern Region WFO Charleston, WV (RLX) are: Boyd, Carter, Greenup and Lawrence.
- Missouri counties (2) to Southern Region WFO Memphis (MEG) are Dunklin and Pemiscot.
- Wyoming counties (2) to Western Region WFO Salt Lake City, UT (SLC) are Uinta; and to Western Region WFO Billings, MT (BYZ), Sheridan.
