CORRECTED NEW ADVANCED WEATHER INTERACTIVE PROCESSING SYSTEM /AWIPS/ ID /RR3HFO/ FOR DAILY COOPERATIVE OBSERVATIONS /SHEF/ IN TABLE 1.

EFFECTIVE THURSDAY JULY 15 2004...AT 800 AM HAWAIIAN STANDARD TIME /HST/...1800 COORDINATED UNIVERSAL TIME /UTC/...THE AWIPS IDENTIFIERS FOR THE PRODUCTS FROM HAWAII LISTED IN TABLE 1 WILL CHANGE. THE CHANGE IS NECESSARY TO REFLECT THE MODERNIZED NATIONAL WEATHER SERVICE /NWS/ WEATHER FORECAST OFFICE /WFO/ ID FOR HONOLULU /HFO/ HAWAII. THE WORLD METEOROLOGICAL ORGANIZATION /WMO/ HEADINGS WILL REMAIN THE SAME.

USERS OF NWS PUBLIC...HYDROLOGIC AND FIRE WEATHER STATEMENTS AND WARNINGS ORIGINATING FROM HAWAII MUST UPDATE THEIR COMMUNICATION SYSTEM DIRECTORIES TO CONTINUE TO RECEIVE THESE PRODUCTS.
