ON TUESDAY NOVEMBER 1 2005 AT 1800 COORDINATED UNIVERSAL TIME /UTC/...ALL  
WEATHER FORECAST OFFICES /WFOS/ IN THE CONTIGUOUS UNITED STATES /CONUS/  
AND THE STATE OF HAWAII WILL DISCONTINUE ISSUING MULTI-PURPOSE SPECIAL  
WEATHER STATEMENTS /SPS/ TO CANCEL COUNTIES...PARISHES...INDEPENDENT  
CITIES AND MARINE ZONES FROM SEVERE THUNDERSTORM AND TORNADO WATCH AREAS.

THE WATCH CANCELLATION INFORMATION PREVIOUSLY CONTAINED IN THE SPECIAL  
WEATHER STATEMENT /SPS/ PRODUCT WILL BE FOUND IN THE WATCH COUNTY  
NOTIFICATION MESSAGE /WCN/ THAT SELECTED WFOS HAVE BEEN ISSUING  
EXPERIMENTALLY SINCE MARCH 8 2005. FOR ADDITIONAL INFORMATION...SEE
