CYCLONE IMPACTS IN THEIR AREA OF RESPONSIBILITY. THIS INCLUDES DATA SUCH
AS RAINFALL...PEAK SUSTAINED WIND...WIND GUSTS...STORM
SURGE...TORNADOES...STRUCTURAL DAMAGE...LOSS OF LIFE AND INJURIES.
