SUBJECT: CHANGES TO FIRE WEATHER ZONE BOUNDARIES IN WASHINGTON AND OREGON: EFFECTIVE JUNE 1 2007

EFFECTIVE FRIDAY JUNE 1 2007 AT 1200 COORDINATED UNIVERSAL TIME /UTC/...THE NWS WEATHER FORECAST OFFICES /WFOS/ IN PORTLAND OREGON /PQR/ AND PENDLETON OREGON /PDT/ WILL SPLIT FIRE WEATHER ZONES THAT COVER BOTH WASHINGTON AND OREGON INTO SEPARATE ZONES DIVIDED BY THE WASHINGTON-OREGON STATE BORDER.

THE PURPOSE OF THIS CHANGE IS TO IMPROVE DISSEMINATION OF FIRE WEATHER FORECASTS AND WARNINGS VIA THE WASHINGTON STATE ACCESS SYSTEM. CURRENTLY...FIRE WEATHER ZONES THAT CROSS THE WASHINGTON-OREGON BORDER ARE IDENTIFIED IN THE PRODUCT HEADER BY AN OREGON STATE ZONE. FOR EXAMPLE...FIRE WEATHER ZONE ORZ601 ALONG THE NORTHERN OREGON AND SOUTHERN WASHINGTON COAST EXTENDS FROM APPROXIMATELY CAPE SHOALWATER ON THE SOUTH WASHINGTON COAST TO LINCOLN CITY ON THE OREGON COAST. THE PROPOSAL IS TO SPLIT ORZ601 AT THE COLUMBIA RIVER...CREATING FIRE WEATHER ZONES WAZ601 AND ORZ601. A SIMILAR SPLIT WOULD BE MADE FOR OTHER FIRE WEATHER ZONES IN THE PORTLAND AND PENDLETON COUNTY WARNING AREAS /CWAS/ THAT CROSS THE WASHINGTON-OREGON STATE BORDER.

ONCE THIS CHANGE HAS BEEN IMPLEMENTED...THE FIRE WEATHER ZONES LISTED IN TABLE 1 WILL BE USED FOR ALL FIRE WEATHER FORECAST PRODUCTS ISSUED BY PORTLAND OR PENDLETON FOR EITHER SIDE OF THE WASHINGTON-OREGON BORDER.
