SUBJECT: MEDFORD OREGON WEATHER FORECAST OFFICE ADDS TWO NEW MARINE ZONES:
EFFECTIVE APRIL 1 2008

EFFECTIVE TUESDAY APRIL 1 2008 AT 0000 COORDINATED UNIVERSAL TIME
/UTC/...OR 1700 PACIFIC DAYLIGHT TIME /PDT/...THE MEDFORD OREGON WEATHER
FORECAST OFFICE /WFO/ WILL ADD TWO ADDITIONAL MARINE ZONES: THE COOS BAY
BAR AND THE CHETCO RIVER BAR.

THE NEW MARINE ZONES WILL ENABLE THE MEDFORD OREGON WFO TO ISSUE MARINE
WEATHER FORECASTS FOR THESE TWO RIVER BARS. THESE FORECASTS WILL
INITIALLY BE FOR TWO DAYS. THE NEW ZONES ARE LISTED IN TABLE 3.
