FLASH FLOOD AND AREAL FLOOD PRODUCTS: EFFECTIVE JULY 1 2008

EFFECTIVE TUESDAY JULY 1 2008 AT 1400 COORDINATED UNIVERSAL TIME
/UTC/...NWS WEATHER FORECAST OFFICES /WFOS/ WILL REMOVE THE TRACKING
INFORMATION LINE /TIME...MOT...LOC/ FROM THE FOLLOWING FLASH FLOOD AND
AREAL FLOOD WARNINGS AND STATEMENTS:

FLASH FLOOD WARNINGS /FFW/
CONVECTIVE FLASH FLOOD STATEMENTS /FFS/
CONVECTIVE AREAL FLOOD WARNINGS /FLW/
AREAL FLOOD ADVISORIES AND AREAL FLOOD STATEMENTS /FLS/

NWS WILL NO LONGER APPEND THE TRACKING INFORMATION LINE THAT BEGINS WITH
THE 16 CHARACTER STRING TIME...MOT...LOC TO THESE FLASH FLOOD AND AREAL
FLOOD WARNINGS AND STATEMENTS BECAUSE STORM TRACKING INFORMATION MAY
INCORRECTLY IDENTIFY HOW AND WHERE FLOODING WILL PROGRESS OVER TIME.

THE TRACKING LINE WILL BE REMOVED ON JULY 1 2008 AT 1400 UTC UNLESS
ADVERSE WEATHER IS AFFECTING AN NWS WFO/S COUNTY WARNING AREA...IN WHICH
CASE...THE WFO WILL IMPLEMENT THE CHANGE AT A MORE SUITABLE TIME.

TORNADO /TOR/...SEVERE THUNDERSTORM /SVR/...SPECIAL MARINE /SMW/ AND
EXTREME WIND /EWW/ WARNINGS AND STATEMENTS /SVS AND MWS/ WILL CONTINUE TO
