SUBJECT: IMPACT OF CHANGE TO STANDARD TIME ON ISSUANCE TIMES OF SEVERAL  
AVIATION WEATHER FORECASTS: EFFECTIVE OCTOBER 30 2005

NOTE: THE FOLLOWING CHANGES HAVE NO IMPACT ON NOAA WEATHER WIRE SERVICE  
SUBSCRIBERS.

ON SUNDAY...OCTOBER 30 2005 AT 200 AM LOCAL TIME...MOST OF THE NATION WILL  
SWITCH FROM DAYLIGHT SAVINGS TIME TO STANDARD TIME. AS A RESULT OF THIS  
CHANGE...THE ISSUANCE TIMES OF SEVERAL PRODUCTS ISSUED BY THE AVIATION  
WEATHER CENTER /AWC/ IN KANSAS CITY MISSOURI AND THE ALASKA AVIATION  
WEATHER UNIT /AAWU/ IN ANCHORAGE ALASKA WILL CHANGE.

THE AVIATION AREA FORECASTS AND AIRMETS LISTED BELOW WILL BE ISSUED ONE  
HOUR LATER WITH RESPECT TO COORDINATED UNIVERSAL TIME /UTC/. IN OTHER  
WORDS...THE LOCAL ISSUANCE TIME REMAINS THE SAME...BUT THE CORRESPONDING  
UTC TIME IS ONE HOUR LATER. THE AFFECTED PRODUCTS AND THE REVISED  
ISSUANCE TIMES ARE LISTED IN TABLES BELOW.

THE COLLABORATIVE CONVECTIVE FORECAST PRODUCT /CCFP/ ISSUED BY THE  
AVIATION WEATHER CENTER /AWC/ WILL END ITS PRODUCTION CYCLE FOR THE YEAR  
ON OCTOBER 30 2005 AT 0300 UTC.
