EFFECTIVE TUESDAY FEBRUARY 26 2008 AT 1200 COORDINATED UNIVERSAL TIME
/UTC/...THE NWS OFFICE IN GRAND JUNCTION COLORADO WILL SUSPEND TAF SERVICE
FOR GUNNISON /KGUC/ AND YAMPA VALLEY /KHDN/ COLORADO. A NOTICE OF
CONCURRENCE FROM THE FEDERAL AVIATION ADMINISTRATION /FAA/ TO SUSPEND
THESE TWO TAFS IS ON FILE AT THE NWS AVIATION SERVICES BRANCH. ACCORDING
TO NWS PROCEDURAL INSTRUCTION 10-813...SECTION 5...A LOCATION MUST HAVE A
COMPLETE OBSERVATION AVAILABLE USING A TOTAL OBSERVATION CONCEPT
/TOC/...GENERALLY IN THE VICINITY OF THE LOCATION...BEFORE A VALID TAF MAY
BE ISSUED. KGUC AND KHDN DO NOT MEET THE REQUIREMENT. THESE TAFS HAVE
BEEN SUSPENDED INDEFINITELY.
